WHEREAS the Minister of Health, after giving 10 days' previous notice of his intention in that behalf, did, under the provisions of the Burial Act, 1853 (16 & 17 Vict. c. 134), as amended by subsequent enactments, make a Representation to His Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Chipping Campden in the County of Gloucester, save with the previous approval of the Minister of Health, should be prohibited, and that burials should be discontinued therein as hereinafter directed: after directed:
