WHEREAS the Church Commissioners have duly prepared and laid before His Majesty in Council a Scheme bearing date the 12th day of April, 1951, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Saint Gabriel, North Acton; Saint Dunstan, East Acton; and All Souls, Harlesden; all in the diocese of London.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Honourable and Right Reverend William, Bishop of London, consents to the proposed arrangements (in testimony whereof he has signed this Scheme):

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Saint Gabriel, North Acton; Saint Dunstan, East Acton; and All Souls, Harlesden; shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme. and delineated on the map annexed to this Scheme.

"The territory to be annexed to the parish of All

"The territory to be annexed to the parish of All Souls, Harlesden:—

"(a) All that part of the parish of Saint Gabriel, North Acton, coloured pink on the map annexed hereto, which lies to the north of the middle of the Acton and Northolt branch line of the British Railways (Western Region).

"(b) All that adjacent part of the parish of Saint Dunstan, East Acton, coloured green on the map annexed hereto, which lies to the north of the middle of the main line of the British Railways (Western Region)."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

"THE SCHEDULE.

"The territory to be annexed to the parish of Saint Saviour, Eltham:

"All that portion of the parish of Eltham (shown by the pink colour on the map) which is bounded on the south by the parish of Saint Andrew, Mottingham, on the west by the parish of Saint Saviour, Eltham, and on the remaining side by an imaginary line commencing at a point on the Saviour, Eltham, and on the remaining side by an imaginary line commencing at a point on the boundary which divides the parish of Saint Saviour, Eltham, from the parish of Eltham, opposite to the western end of the wall or fence which divides close numbered 359 from close numbered 331 on the map annexed hereto, and continuing thence eastwards along the said wall or fence and along the wall or fence which divides close numbered 330 from close numbered 329 to its eastern end and continuing thence eastwards in a straight line to a point in the middle of Court Road opposite to the western end of the wall or fence which divides close numbered 104 from close numbered 103 and continuing thence southwards along the middle of continuing thence southwards along the middle of Court Road to the boundary which divides the parish of Eltham from the parish of Saint Andrew, Mottingham."
