"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parishes of Stopsley, Luton and Saint Matthew, High Town, Luton, in the diocese of Saint Albans.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas there is no consecrated church within the area and the church of Saint Christopher therein has been approved by us, the said Church Commissioners, as suitable to be the parish church of the new parish and is intended to be consecrated:

"Now, therefore, with the consent of the Right Reverend Michael, Bishop of Saint Albans (in testi-mony whereof he has set his hand and affixed his episcopal seal to this Scheme) we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

### "1. Constitution:

"(a) As from the licence thereto of a minister the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual purposes until the consecration of the church of Saint Christopher therein situated therein situated.

"(b) As from the date of the consecration of the said church the area shall become a new parish.
"(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Christopher, Round Green, Luton.'

# "2. Archdeaconry and Rural Deanery:

"The parish shall be in the Archdeaconry of Bedford and in the rural deanery of Luton.

"All those portions of the parishes of Stopsley, Luton and Saint Matthew, High Town, Luton (coloured pink, blue and yellow respectively on the plan annexed hereto) which taken together are bounded by an imaginary line commencing at a point in the middle of Hart Lane on the boundary which divides the parish of Saint Matthew, High Town, Luton, from the parish of Luton opposite to the middle of the western end of Hart Way and continuing thence eastwards along the middle of Hart Way to a point in the middle of Abbotswood Road opposite to the eastern end of Hart Way and continuing thence generally north-eastwards firstly along the middle of Abbotswood Road and then along the middle of Bloomfield Avenue to its north-eastern end and continuing thence in the same straight line to a point in the middle of the proposed Eastern By Pass Road and continuing thence north-west-wards along the middle of the Eastern By Pass Road to a point opposite to the middle of the eastern end of Bradgers Hill and continuing thence westwards along the middle of Bradgers Hill to a point in the middle of Old Bedford Road

opposite to the western end of Bradgers Hill and continuing thence southwards along the middle of Old Bedford Road to a point in the middle of Stockingstone Road on the boundary which divides the parish of Saint Matthew, High Town, Luton, from the parish of Stopsley and continuing thence firstly eastwards then southwards and then eastwards along the last mentioned boundary to a point where it meets the footpath leading to Kingston Road and continuing thence southwards along the middle of the last mentioned footpath to a point where it meets the walls or fences at the rear of the houses on the north-western side of Kingston Road and continuing thence firstly eastwards and then north-eastwards along the last mentioned walls or fences and then in the same straight line to a point in the middle of Richmond Hill and continuing thence generally southeastwards along the middle of Richmond Hill to the boundary which divides the parish of Saint Matthew, High Town, Luton, from the parish of Stopsley and continuing thence along the last mentioned boundary to a point opposite to the middle of the north-western end of Hart Lane and continuing thence south-eastwards along the middle of the western end of Hart Way."
