(2) An Order under section 14 of the Special Roads Act, 1949, the effect of which will be:—

(a) to provide for the construction by the Minister of a new link road in the Rural District of Millom in the County of Cumberland to connect the road leading from Bootle to Hyce-moor to the new trunk road.

(b) that the Council of the County of Cumberland will become the highway authority for the new link road on the date on which notice is given by the Minister to the Council that that road is opened for through traffic.

##### LONDON TRAFFIC ACT, 1924.

Notice is hereby given that the Minister of Transport proposes, in exercise of the powers conferred upon him by section 10 of the London Traffic Act, 1924, as amended by section 63 of the London Passenger Transport Act, 1933, to make Regulations to prohibit the driving of any vehicle the weight of which laden or unladen exceeds 30 cwts. on that length of Lower Ham Road which lies between its junction with Kings Road and its junction with Richmond Road in the Royal Borough of Kingston-upon-Thames.

Exceptions will be provided in the Regulations to permit the driving on the road of any vehicle being used for the conveyance of persons, goods or merchandise to or from any premises situate on or adjacent to the road or in connection with any building operation or demolition, the removal of any obstruction to traffic or the maintenance of the road and the services therein.
