In accordance with Section 77 of the National In accordance with Section 77 of the National Insurance Act, 1946, the National Insurance Advisory Committee give notice that they have received from the Joint Authority (comprising the Minister of National Insurance and the Minister of Labour and National Insurance for Northern Ireland) for consideration and report thereon the preliminary draft of regulations entitled The National Insurance (Overlapping Benefits) Amendment Regulations, 1951.

## EXPLANATORY NOTE.

These Regulations amend the National Insurance (Overlapping Benefits) Regulations, 1948, by reducing the number of personal benefits, payable out of public funds otherwise than under the National Insurance Act, 1946 (as amended by the National Insurance Act, 1951) by reference to which personal dependency benefits under that Act (as so amended) are required to be adjusted. They also relax, in certain cases, the provisions of the amended regulations requiring an adjustment of a child's allowance; and they substitute new provisions for adjusting benefit for part of a week. The other amendments are of a minor or consequential character. These Regulations amend the National Insurance
