1. Age.
Candidates must be at least 20 and under 60 years of age on 1st January, 1951, i.e., they must have been born on or after 2nd January, 1891, and on or before 1st January, 1931.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour. Provided that a candidate will not be eligible for an appointment under the Admiralty, War Office, Air Ministry or Ministry of Supply unless he or she is a natural-born British subject and born within the United Kingdom or in one of the self-governing Dominions of parents also born within the United Kingdom or in one of the self-governing Dominions, except when the circumstances are such as to justify a departure from the general rule, in which case, provided the candidate satisfies the conditions prescribed by the preceding paragraphs, he
