WHEREAS His Majesty, in pursuance of the Regency Acts, 1937 and 1943, was pleased, by Letters Patent dated the Twenty-seventh day of September, 1951, to delegate and grant unto Her Majesty The Queen, Her Royal Highness The Princess Elizabeth Duchess of Edinburgh, Lady of the Most Noble Order of the Garter C.I., Her Royal Highness The Princess Margaret, C.I., His Royal Highness The Duke of Gloucester, K.G., K.T., K.P., G.M.B., G.C.M.G., G.C.V.O., and Her Royal Highness The Princess Royal, C.I., G.C.V.O., G.B.E., or any two of them, as Counsellors of State, full power and authority during the period of His Majesty's illness to summon and hold on His Majesty's behalf His Privy Council and to signify thereat His Majesty's approval of any matter or thing to which His Majesty's approval in Council is required:

And whereas the Church Commissioners have duly prepared and laid before His Majesty in Council a Scheme bearing date the 16th day of August, 1951, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and of the Union of Benefices Measures, 1923 to 1936, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Honourable and Most Reverend Cyril, Archbishop of York (in witness whereof he has signed the Scheme), for effecting the union of the benefice of Stillingfleet and the benefice of Naburn both situate in the diocese of York.

"SCHEME

"1. *Union of Benefices.* The benefice of Stillingfleet and the benefice of Naburn shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Stillingfleet with Naburn', but the parishes of the said benefices shall continue in all respects distinct.

"2. *Taking effect of union.* The union shall take effect upon the vacation by the Reverend Benjamin William Crowe of the benefice of Cawood (now held by him in plurality with the benefice of Stillingfleet) and the said Reverend Benjamin William Crowe if he is then incumbent of the said benefice of Stillingfleet shall with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"3. *Parsonage house.* (1) Upon the union taking effect the house at present under erection as a parsonage house for the benefice of Stillingfleet shall become the house of residence of the incumbent of the united benefice. (2) If the parsonage house now belonging to the benefice of Naburn shall not have been sold or disposed of under the Parsonages Measure, 1938, before the taking effect of the union it and the site and appurtenances thereof and the grounds usually occupied and enjoyed therewith shall be sold and disposed of by us, the said Church Commissioners, after the union has taken effect at such time or times and in such manner in all respects as to us shall seem expedient. (3) If, pursuant to the last preceding paragraph, the said parsonage house be sold by us aforesaid the net proceeds of the sale shall be applied towards the cost of provision of the house designated as aforesaid as the house of residence of the united benefice or towards discharging any loan obtained for that purpose.

"4. *Patronage.* After the union has taken effect the right of presentation to the united benefice shall be exercised by the patrons of the two benefices alternately, the patron of the benefice of Stillingfleet having the first presentation to the united benefice to be made after the union."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1936, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved at the Council held under the authority of the said Letters Patent:

Now, therefore, Her Majesty The Queen and Her Royal Highness The Princess Elizabeth, being authorized thereto by the said Letters Patent, have taken the said Scheme into consideration, and do hereby, by and with the advice of His Majesty's Privy Council, on His Majesty's behalf affirm the said Scheme and, order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

And whereas the Church Commissioners have duly prepared and laid before His Majesty in Council a Scheme bearing date the 16th day of August, 1951, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and of the Union of Benefices Measures, 1923 to 1936, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consents of the Right Reverend Alfred, Bishop of Bradford, and of the Right Reverend Thomas, Bishop of Carlisle (in witness whereof they have respectively signed the Scheme), for effecting the union of the benefice of Sedbergh in the diocese of Bradford and the benefice of Killington in the diocese of Carlisle.

"SCHEME.

"1. *Union of Benefices.* The benefice of Sedbergh and the benefice of Killington shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Sedbergh with Killington', but the parishes of the said benefices shall continue in all respects distinct.

"2. *Taking effect of union.* Upon the day when any Order of Your Majesty in Council ratifying this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend John Alfred Victor Wallace if he is then incumbent of the said benefice of Sedbergh shall with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"3. *Parsonage House.* Upon the union taking effect the parsonage house at present belonging to the benefice of Sedbergh shall be the house of residence of the incumbent of the united benefice.

"4. *Patronage.* With the consents of the Reverend Alexander Pemberton Kirkpatrick as incumbent of the united benefice of Kirkby Lonsdale with Mansergh being the patron of the benefice of Killington and of the Master, Fellows and Scholars of the College of the Holy and Undivided Trinity in Cambridge, being the patrons of the benefice of Sedbergh (in testimony whereof the respective patrons have executed this Scheme) the patronage of the said benefice of Killington shall, upon the union taking effect, be surrendered to the patrons of the said benefice of Sedbergh, to the intent that the patronage of the united benefice shall belong wholly to the patrons of the said benefice of Sedbergh.

"5. *Diocese, Archdeaconry and Rural Deanery.* The united benefice shall be in the diocese of Bradford, the archdeaconry of Craven and the rural deanery of Sedbergh."
