(2) Every such person shall enter in a book to be kept by him for that purpose the description and price of all articles purchased or otherwise acquired by him, and the name, etc., of the person from whom the same was purchased or acquired.
(3) Every such person not so registering or keeping such book as aforesaid shall be liable to a sensity not exceeding 55 and to a daily penalty not

penalty not exceeding £5 and to a daily penalty not exceeding £2.

(4) Any officer of the local authority duly autho-rised in writing shall have access at all reasonable times to such places of business as aforesaid to inspect the same and the books required to be kept. G. L. DAY, Town Clerk.
