WHEREAS the Church Commissioners have duly prepared and laid before His Majesty in Council a Scheme bearing date the 18th day of October, 1951, in the words and figures following, that is to say:—

"We, the Church Commissioners, in pursuance of the Church Patronage Act, 1870, and the Acts mentioned therein, have prepared the following Scheme for effecting a transfer of the interest hereinafter mentioned in the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said Benefice') of Christ Church, Emery Down, in the County of Southampton and in the diocese of Winchester.

"Whereas we are satisfied that Patrick Hare Vivian Twist, of 3, The Quadrant, Coventry, Warwickshire, Esquire, and Francis Walter Moyle, of Allesley, near Coventry, Warwickshire, Clerk in Holy Orders, as the executors of the late Harvey William Mapleton-Bree, Esquire, are entitled to exercise the alternate right of patronage of and presentation to the said Benefice:

"And whereas the said Patrick Hare Vivian Twist and Francis Walter Moyle desire, in accordance with the intentions expressed in the will of the said Harvey William Mapleton-Bree, to transfer their said interest in the advowson of the said benefice to the Bishop of Winchester for the time being and are consenting to this Scheme (in testimony whereof they have executed the same):

"And whereas we are satisfied that the transfer will tend to make better provision for the cure of souls:

"Now, therefore, with the consent of the Right Reverend Mervyn, Bishop of Winchester (in testimony whereof he has executed this Scheme), we, the said Church Commissioners, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the said interest of the said Patrick Hare Vivian Twist and the said Francis Walter Moyle in the ownership of the advowson or perpetual right of patronage of and presentation to the said benefice shall be transferred to the said Mervyn, Bishop of Winchester, and his successors in the same Bishopric and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the Bishop of Winchester for the time being."

WHEREAS the Church Commissioners have duly prepared and laid before His Majesty in Council a

Scheme bearing date the 18th day of October, 1951, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parish of South Hylton (or Ford) in the diocese of Durham.

"SCHEME.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas there is no consecrated church within the area and the church of The Good Shepherd therein has been approved by us, the said Church Commissioners, as suitable to be the parish church of the new parish:

"Now, therefore, with the consent of the Right Reverend Alwyn, Bishop of Durham (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

"1.—(a) As from the licence thereto of a Minister, the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual purposes until the consecration of the church of The Good Shepherd therein situated,

"(b) As from the date of the consecration of the said church the area shall become a new parish.

"(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of The Good Shepherd, Bishopwearmouth'.

"2. *Archdeaconry and Rural Deanery*:

"The parish shall be in the archdeaconry of Durham and in the rural deanery of Wearmouth.

"THE SCHEDULE.

"The area (shown by the pink colour on the map) comprising:—

"All that portion of the parish of South Hylton (or Ford) which is bounded upon part of the east by the parish of St. Luke, Pallion, upon the north by the parish of Southwick and the parish of St. Margaret, Castletown, North Hylton and upon the remaining sides by an imaginary line commencing at a point in the middle of the River Wear where the County Borough Boundary diverges south eastwards from the boundary which divides the parish of St. Margaret, Castletown, North Hylton, from the parish of South Hylton (or Ford) and extending thence south eastwards along the said County Borough Boundary to the middle of the Penshaw Branch of the British Railways (North Eastern Region) and continuing thence south westwards along the middle of the said railway to a point opposite to the north western end of the wall or fence which divides close numbered 48 from close numbered 49 and continuing thence generally south eastwards first to and then along the last mentioned wall or fence and along the walls or fences which divide closes numbered 47, 81 and 82 from closes numbered 80 and 79 to the wall or fence which divides close numbered 82 from close numbered 90 and continuing thence south westwards along the last mentioned wall or fence and along the wall or fence which divides close numbered 82a from close numbered 90 to the wall or fence which divides close numbered 90 from close numbered 89 and continuing thence south eastwards along the last mentioned wall or fence to Hylton Lane and continuing thence first in the same direction to the middle of Hylton Lane and then eastwards along the middle of the last mentioned lane and the middle of Hylton Road to a point opposite to the northern end of the walls or fences which divide closes numbered 97, 98 and 99 from closes numbered 226, 234 and 235 and continuing thence southwards along the last mentioned walls or fences (thereby following the wall or fence running between the Sunderland Rural District Isolation Hospital and the Sunderland Borough Hospital) to the boundary which divides the parish of South Hylton (or Ford) from the parish of St. Gabriel, Bishopwearmouth, and continuing thence south eastwards along the last mentioned boundary to a point opposite to the south eastern end of the western wall or fence of Bishopwearmouth Cemetery and continuing thence north westwards to and then along
