"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and of the Union of Benefices Measures, 1923 to 1936, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend William, Bishop of Salisbury, (in witness whereof he has signed the Scheme), for effecting the union of the henefice of Edington and the benefice of Imber both situate in the diocese of Salisbury. situate in the diocese of Salisbury.

"1. Union of Benefices and Parishes. The parsonage house at present belonging to the benefice of Edington shall be the house of residence of the incumbent of the be the house of residence of the incumbent of the united benefice, and the parsonage house at present belonging to the benefice of Imber and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall, as soon as conveniently may be, be sold and disposed of by us, the said Church Commissioners, at such time and in such manner in all respects as to us shall seem expedient and the net proceeds of such sale shall be held by us as part of the endowments of the united benefice ments of the united benefice.

"6. Archdeaconry and Rural Deanery. The united benefice shall be in the Archdeaconry of Wilst and in the rural deanery of Devizes."

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parish of Saint Michael and All Angels, Belgrave, in the diocese of Leicester.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map

in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas we have not approved any consecrated church within the area as suitable to be the parish church of the new parish:

"Now, therefore, with the consent of the Right Reverend Guy Vernon, Bishop of Leicester, (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say: propose as follows, that is to say:-

"1. Constitution:

"(a) As from the date of the licence thereto of a minister, the area defined in the subjoined Schedule

minister, the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual purposes.

"(b) As from the date of the consecration of a church within the area approved by us, the said Church Commissioners, as suitable to be a parish church or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish.

"(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Gabriel, Leicester.'

"2. Archdeaconry and Rural Deanery:
