The KING has been pleased by Letters Patent under the Great Seal bearing date the 28th day of November, 1951, to grant to the Right Honourable Baron Simonds, Lord High Chancellor of Great Britain, a contingent Annuity of £3,750, in accordance with the Lord Chancellors Pension Act, 1832, as affected by the Administration of Justice (Pensions) Act. 1950.

### TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank

of England on Friday, the 21st December, 1951, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £170,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 24th December, 1951, to Saturday the 29th December, 1951, inclusive, and will be due

the 29th December, 1951, inclusive, and will be due 91 days after date.
3. The Bills will be issued and paid at the Bank

of England.

4. Each tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

Notification will be sent by post, on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Monday, 24th December, 12 noon, and Saturday, 29th December, 11.30 a.m.) on the day on which the relative Bills are to be dated.
