RECRUITMENT UNDER NORMAL REGULATIONS TO THE SITUATION OF CARTOGRAPHICAL DRAUGHTSMAN OR SURVEYOR IN THE ORDNANCE SURVEY.

1. Age.

Section I.
Candidates must be at least 16 and under 18 years of age on 1st March, 1952.

Section II.

Candidates must be at least 18 and under 25 years of age on 1st March, 1952.

But (a) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct the period of such service from his actual age;

(b) a candidate who has served in H.M. Forces otherwise than on a regular or short-service engagement may deduct the period of such service from his actual age, up to a maximum of two years. 2. Sex.

(i) Both men and women are eligible, provided that the number of vacancies available for women

may be restricted.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before the 15th October, 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without house of the second of or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

3. Nationality.

Candidates must be British subjects. They must also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must

(i) have at least one parent who is or was at

death a British subject; or
(ii) have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last preceding years the date their

eight years preceding the date of their appointment.

(b) If naturalised British subjects, they must have resided in His Majesty's dominions and/or been employed elsewhere in the service of the Crown for at last five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph, they must satisfy the Commissioners that they are so closely connected with His Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Health and Character.

Successful candidates must satisfy the Civil Service Commissioners as to their health and character.
