 "Intending passenger" means any person waiting at a stopping place on a trolley vehicle route for the purpose of becoming a passenger on a trolley vehicle or who is about to enter a trolley vehicle for that purpose. for that purpose. "Conductor" includes any officer or servant of

the Corporation having the charge of or helping in the charge of a trolley vehicle.

"Driver" means any officer or servant of the Corporation driving or helping to drive a trolley vehicle.

"Authorised person" means any officer or servant of the Corporation (including the Con-ductor) on duty upon or in connection with the

"Premises" means a cloakroom, room or shed for the storage of bicycles, tricycles and other vehicles or any shelter or other accommodation provided in connection with any service of trolley

provided in connection with any service of trolley vehicles of the Corporation. 2. The Interpretation Act, 1889, shall apply to the interpretation of these Byelaws as it applies to the interpretation of an Act of Parliament. 3. When a trolley vehicle is carrying passengers or waiting to pick up passengers a passenger or intending passenger shall not— (i) use obscene or offensive language or conduct himself in a riotous or disorderly manner; (ii) enter or alight from the trolley vehicle other-wise than by the doors or openings provided for

wise than by the doors or openings provided for

the purpose; (iii) when entering or attempting to enter the trolley vehicle wilfully and unreasonably impede passengers seeking to enter the trolley vehicle or to alight therefrom;

passengers seeking to enter the trolley vehicle or to alight therefrom; (iv) enter or remain in or on the trolley vehicle when requested not to do so by an authorised person on the ground that the trolley vehicle is carrying its full complement of passengers; (v) travel in or on the upper deck of the trolley vehicle unless he occupies a seat provided for that purpose, or in or on any part of the trolley vehicle not provided for the conveyance of passengers; (v) wilfully do or cause to be done with respect to any part of the trolley vehicle or its equipment anything which is calculated to obstruct or inter-fere with the working of the trolley vehicle or to cause injury or discomfort to any person; (vii) when the trolley vehicle is in motion distract the driver's attention without reasonable cause or speak to him unless it is necessary to do so in order to give directions as to the stopping of the trolley vehicle; (viii) give any signal which might be interpreted by the driver as a signal from the conductor to start; (i) spit upon or from or wilfully damage soil

start :

(ix) spit upon or from or wilfully damage, soil or defile any part of the trolley vehicle;

or defile any part of the trolley vehicle; (x) when in or on the trolley vehicle distribute printed or similar matter of any description or distribute any article for the purpose of advertising; (xi) wilfully remove, displace, deface or alter any number plate, notice board fare table, route indica-tor or destination board or any printed or other notice or advertisement in or on the trolley vehicle; (xii) when in or on the trolley vehicle to the annoyance of other persons use or operate any noisy instrument or make or combine with any other person or persons to make any excessive noise other person or persons to make any excessive noise

(xiii) when in or on the trolley vehicle throw any money to be scrambled for by any person on the road or footway; or throw out of the trolley vehicle any bottle liquid or litter or any article or thing likely to annoy persons or to cause danger or injury to any person or property;

(xiv) throw any article from the trolley vehicle or attach to or trail from the trolley vehicle any streamer, balloon, flag or other article in such manner as to overhang the road; (xv) wilfully obstruct or impede any authorised

person;

(xvi) smoke or carry a lighted pipe, cigar or cigarette in or on any part of the trolley vehicle in or on which a notice is exhibited that smoking

is prohibited; (xvii) when in or on the trolley vehicle beg, sell or offer for sale any article; (xviii) if his condition is such as to be offensive

(xviii) if his condition is such as to be offensive to passengers, or the condition of his dress or clothing is such that it may reasonably be expected to soil or injure the linings or cushions of the trolley vehicle or the clothing of other passengers, enter or remain in or on the trolley vehicle after an authorised person shall have requested him either not to enter or to leave the trolley vehicle and in such latter case shall have tendered to him the amount of any fare previously paid; provided that on trolley vehicles specially run for artisans, mechanics or daily labourers no passenger shall be prevented from entering or remaining in or on the trolley vehicle under the provisions of this

Byelaw, on the ground of the condition of his dress or clothing, if such condition is solely due to the nature of his employment;

(xix) enter or travel in or on a trolley vehicle (XIX) enter or travel in or on a troney venicle with loaded firearms, or any dangerous or offensive article or, except with the consent of an authorised person, bring into or on to the trolley vehicle any bulky or cumbersome article or place any such article elsewhere in or on the trolley vehicle than art directed by an authorised person.

(xx) bring any animal into or on to the trolley vehicle without the consent of an authorised person or retain any animal in or on the trolley vehicle after being requested by an authorised person to remove it or place any animal elsewhere in or on the trolley vehicle than as directed by an authorised person;

(ii) any ticket which has been issued to another person if such ticket bears thereon an indication that it is not transferable; or

(iii) any period or season ticket which has expired, with intent to avoid payment of a fare. (b) Every passenger shall:-

(b) Every passenger shall:— (i) unless he is the holder of a ticket in respect of that journey, immediately upon demand, declare the journey he intends to take or has taken and pay the conductor the fare for the whole of such journey and accept the ticket provided therefor; (ii) if requested by the conductor, leave the trolley vehicle on completion of the journey the fare for which he has naid:

fare for which he has paid;

(iii) show his ticket, if any, when required to do so by any authorised person, or, if he fails so to show his ticket, pay the fare for the journey taken or to be taken by him; (iv) if required to do so surrender his ticket to any authorised person at the end of the journey

any authorised person at the end of the journey covered by that ticket;

(v) if required to do so surrender any period or season ticket held by him at the expiry of the period for which it was issued to him; (vi) if required to do so surrender any ticket held by him either on completion of the journey or journeys covered by that ticket or in exchange for a new ticket covering the journey exchange for a new ticket covering the journey or journeys he is still entitled to take;

5. Byelaw 3 (i), (ix), (x), (xi), and (xii) of these Bye-laws shall extend and apply to the premises of the Cor-poration as if the words "when a trolley vehicle is carrying passengers or waiting to pick up passengers" were omitted therefrom and as if references to a trolley vehicle and to an intending passenger included references to those premises and to a person waiting on those premises respectively on those premises respectively.

6. A passenger not being an artisan, mechanic or daily labourer within the true intent and meaning of the statutory provision relating to the Corporation shall not use or attempt to use any ticket intended only for such artisans, or mechanics, or daily labourers.

7. No person except with the leave of an author-ised person shall board or attempt to board a trolley vehicle which is disabled or otherwise not in service for the carriage of passengers.

8. No person shall commit any nuisance in, on or against any trolley vehicle or premises used in connection with the trolley vehicle system.

9. A conductor shall to the best of his ability take steps whenever necessary to enforce these Byelaws and to prevent the breach thereof.

10. Any person contravening these Byelaws shall be liable to a penalty not exceeding forty shillings and may be removed from the trolley vehicle or premises as the case may be by an authorised person, or on the request of an authorised person, by any police constable constable.

11. There shall be placed and kept placed in a conspicuous position inside each trolley vehicle and premises in use a printed copy of these Byelaws.

12. These Byelaws shall come into force on the 1st day of May, 1952.
