Beryllium metal windows for X-ray tubes.

Synthetic organic chemicals, analytical reagents, other fine chemicals and chemicals manufactured by fermentation processes, the following:—

Aluminium chloride (anhydrous). mono Chlorobenzene. 2-Ethylbutan-1-ol (a hexyl alcohol). mono Nitroethane. Tetrachloroethylene.

The Order which comes into operation on the 25th January, 1952, is entitled the Safeguarding of Industries (Exemption) (No. 1) Order, 1952, and is published as Statutory Instruments, 1952, No. 87.
