- (a) are sums which have been or are about to be repaid prematurely at par to the local authorities by borrowers whose advances under the enactments mentioned were financed out of loans from the Public Works Loan Board, and
- (b) are applied pro rata in discharge or reduction of the loans from the Public Works Loan Commissioners out of which the relative advances were financed by the local authority.
