Notice is hereby given that the Minister of Housing and Local Government, in exercise of powers conferred by Section 23 of the Town and Country Planning Act, 1944, as incorporated with the Town and Country Planning Act, 1947, has prepared in draft and proposes to make an Order extinguishing the public rights of way over parts of Bank of England Place and Union Street, Plymouth.
