The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

REGULATIONS FOR THE RECRUITMENT OF TECHNICAL CLERKS IN HER MAJESTY'S STATIONERY OFFICE.

1. Candidates must be at least 22 and under 28 years of age on the 1st March, 1952. But

(a) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct the period of such service from his actual age;

(b) a candidate who has served in H.M. Forces otherwise than on a regular or short-service engagement may deduct the period of such service from his actual age, up to a maximum of two years;

(c) candidates who have served in any established post to which they were admitted with the Certificate of the Civil Service Commissioners, or who have served on established conditions except for sick leave and pension in a post to which such a Certificate would normally apply, may deduct from their actual age any time not exceeding two years which they may have spent in such service.

2. (i) Both men and women may compete under these Regulations.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October, 1946, or who are widows or divorced or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

3. Candidates must be British subjects. They must also satisfy one of the following conditions:—

(a) If natural-born British subjects, they must either

(i) have at least one parent who is, or was at death, a British subject; or

(ii) have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(b) If naturalised British subjects, they must have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph, they must satisfy the Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Candidates must have served an apprenticeship of at least five years to the Letterpress or Book-binding Trade, or have had practical training for the same period in the production of Printing or Binding; and they must have been recently and for a sufficient time in continuous employment in the trade. A candidate's training and experience must accord with the branch for which he (or she) is competing. Successful candidates, before the issue of their certificates of qualification, will be required to provide proof, in the form of indentures or certificates of service, of their eligibility under this Regulation. If it is then found that they do not satisfy the requirements they cannot be appointed; the decision of the Commissioners will be final.

5. After the last day for application has been reached, all applications will be scrutinised and a list of such candidates as appear from their application forms to be suitable for the duties of the posts in question will be settled by agreement between the Civil Service Commissioners and the Controller of Her Majesty's Stationery Office.

6. Candidates who are accepted will be admitted to a competitive examination in the following subjects:—

1. English Composition (including handwriting and orthography).

2. Arithmetic.

3. Technical knowledge.

Candidates must pass to the satisfaction of the Civil Service Commissioners in Technical knowledge and in the examination as a whole. Of those candidates

who obtain the highest total marks in the written examination, a certain number (to be determined by the Civil Service Commissioners) will be admitted to the second part of the competition, which will be held in London only. This will consist of an informal oral test of the candidate's technical knowledge of the subject in which he is competing, followed by an interview for the assessment of personal qualities before a board on which the Commissioners and Her Majesty's Stationery Office will be represented. The oral test and the interview for each candidate will normally be on the same day, and may, at the discretion of the Commissioners, be combined into a single interview at which technical knowledge and personal qualities will be assessed simultaneously. The Interview Board will award marks which will take into account both the candidate's personal qualities and his technical knowledge as shown at the interview.

The order of merit of the candidates will be determined by their total marks in the whole competition, except that candidates who fail at the interview to reach a standard acceptable to the Interview Board will be declared unsuccessful whatever their aggregate.

7. Successful candidates must satisfy the Civil Service Commissioners as to their health and character.

8. Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

9. Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons (except as referees to be named by them in their application form) will disqualify them for appointment. The Selection Board will disregard recommendations from persons who are not personally acquainted with the candidate's work.

10. A fee of 15s. will be required from every candidate admitted to the written examination.

REGULATIONS FOR THE RECRUITMENT BY OPEN COMPETITIVE EXAMINATION OF ASSISTANT TRAFFIC SUPERINTENDENTS (MALE AND FEMALE) IN THE TELECOMMUNICATION SERVICE OF THE POST OFFICE.

1. Age.

Candidates must be at least 17½ and under 23½ years of age (a half-year equals six calendar months) on the 1st March, 1952.

But

(a) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct the period of such service from his actual age;

(b) a candidate who has served in H.M. Forces otherwise than on a regular or short-service engagement may deduct the period of such service from his actual age, up to a maximum of two years;

(c) candidates who have served in any established post to which they were admitted with the Certificate of the Civil Service Commissioners, or who have served on established conditions except for sick leave and pension in a post to which such a certificate would normally apply, may deduct from their actual age any time not exceeding two years which they have spent in such service before 1st March, 1952.

2. Sex and Marriage.

(i) Both men and women may compete under these Regulations.

3. Nationality.

Candidates must offer all the compulsory subjects (1) to (4) and any two subjects chosen from the optional subjects (5) to (11).

Every candidate must attain in each subject he or she offers, and in the examination as a whole, such a standard as to satisfy the Civil Service Commissioners.

Of those who obtain the highest aggregate marks in the Written Examination a certain number to be determined by the Commissioners will be admitted to Part II of the examination. The order of merit of the candidates will be determined by the aggregate marks in the whole examination.

Of the vacancies to be filled not less than fifteen per cent. will be reserved for candidates who reach a standard satisfactory to the Commissioners and who

(a) have completed, by 1st March, 1952, a period of not less than three years' continuous full-time service in H.M. Armed Forces of which not less than one year must have been whole-time voluntary service entered into for a fixed period (including in the case of officers a permanent commission); or

(b) have contracted to complete a fixed period of whole-time voluntary service (including in the case of officers a permanent commission) which would have qualified under (a) and been invalided before completing that period.

6. Candidates trained as Teachers.

Candidates who have been trained as teachers and upon whose training public money has been spent, cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

TRUNK ROADS ACT, 1946.

SPECIAL ROADS ACT, 1949.

The Carlisle—Sunderland Trunk Road (Shields Road, Heworth, Improvements) Order, 1952.

The Minister of Transport hereby gives notice that he has made an Order under section 14 of the Special Roads Act, 1949, the effect of which is:—

(a) to provide for the re-alignment of the carriageway and footpaths of Shields Road at Heworth in the County of Durham for a distance of approximately 90 yards from its junction with the Carlisle—Sunderland Trunk Road;

(b) to provide for the stopping up of parts of the carriageway of Shields Road aforesaid measuring approximately 1,800 square yards and 500 square yards on its eastern and western sides respectively at its junction with the said Trunk Road.

LONDON TRAFFIC ACT, 1924.

Notice is hereby given that the Minister of Transport proposes, in exercise of the powers conferred upon him by section 10 of the London Traffic Act, 1924, as amended by section 63 of the London Passenger Transport Act, 1933, to make Regulations to—

I. Prohibit waiting by vehicles between the hours of 9 a.m. and 6 p.m. on any day other than a Sunday in:—

(a) that length of Station Road, Epping, which lies between its junction with High Street and its junction with Hemnall Street; and

(b) that length of the said Station Road which lies between its junction with Nichol Road and its junction with the said Hemnall Street.

Exemptions will be provided in the Regulations to enable a vehicle to wait for so long as may be necessary (a) for a person to board or alight from such vehicle; (b) to enable goods to be loaded onto or unloaded from such vehicle; or (c) to enable such vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic or the maintenance of the road or the services therein.

II. Appoint a street parking place in the Urban District of Epping by the addition to the Second Schedule to the London Traffic (Parking Places) Consolidation Regulations, 1950, of the following item:—

Hartland Road: From 8 a.m. to 8 p.m., on south side, from a point 10 yards east of Station Road eastwards for 70 yards. "B."

Severn River Board.

Strine Internal Drainage District.

Notice is hereby given that the Minister of Agriculture and Fisheries, in exercise of the powers conferred upon him under Section 4 (3) of the Land Drainage Act, 1930, as applied by the River Boards Act, 1948, proposes to make an Order confirming with a modification, a Scheme submitted to him by the Severn River Board under Section 4 (1) (b) of the Act, making provision for the following matters:—

Borough of Middleton (Food) Order, 1952.

NOTICE is hereby given that the Minister of Health, on the application of the Council of the Borough and in pursuance of the powers conferred on him by section 14 of the Food and Drugs Act, 1938, has made an Order dated the 14th January, 1952, declaring the 1st day of April, 1952, as the date on which the provisions of section 14 of the Act of 1938 shall come into force in the Borough.

Section 14 of the Act provides for the registration by the local authority of premises used for the sale, or the manufacture for the purpose of sale, of ice-cream or the storage of ice-cream intended for sale; or the preparation or manufacture of sausages or potted, pressed, pickled or preserved food intended for sale.

Any person who uses any premises for the above purposes without prior registration by the local authority shall be guilty of an offence and is liable in the case of a first offence to a fine not exceeding twenty pounds and, in the case of a subsequent offence, to a fine not exceeding one hundred pounds, or to imprisonment for a term not exceeding three months, or to both such a fine and such imprisonment.

The section further provides that if any premises do not satisfy the provisions of section 13 of the Act as to rooms where food intended for sale is prepared or stored, etc., the local authority may refuse to register the premises, and a right of appeal to a Court of Summary Jurisdiction is given to any person so aggrieved.

Provisos exempting certain classes of premises from the above provisions are included in the section.

Upon any change in the occupation of premises registered in accordance with the section, the incoming occupier shall give notice of the change if he intends to use them for the purpose for which they are registered. Any person failing so to do is liable to a penalty not exceeding five pounds.

As from the first day of April, 1952, the provisions of section 116 of the Lancashire County Council (Rivers Board and General Powers) Act, 1938, shall cease to have effect within the Borough, but any premises which immediately before the repeal of those provisions were registered thereunder for any of the purposes mentioned above shall be deemed to have been registered under section 14 (1) of the Food and Drugs Act, 1938, for that purpose.
