WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 21st day of February, 1952, in the words and figures following, that is

1952, in the words and figures following, that is to say:
"We, the Church Commissioners, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend John, Bishop of Derby (in witness whereof he has signed the Scheme), for effecting the union of the benefice of Dalbury with Long Lane and the benefice of Trusley both situate in the diocese of Derby.

" SCHEMB.

"1. Union of Benefices. The benefice of Dalbury with Long Lane and the benefice of Trusley shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Dalbury, Long Lane and Trusley', but the parishes of the said benefices shall continue in all respects distinct.

"2. Taking effect of union. Upon the day when

Upon the day when any Order of Your Majesty in Council ratifying this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Laurence Tuckley if he is then Incumbent of the said benefice of Dalbury with Long Lane shall with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"3. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Dalbury with Long Lane shall be the house of residence of the incumbent of the united benefice.

"4. Patronage. After the union has taken effect

After the union has taken effect the right of presentation to the united benefice shall be exercised in a recurring series of three turns, the patron of the benefice of Trusley having the first turn, the patron of the benefice of Dalbury with Long Lane who is now entitled to make the next presentation thereto having the second turn and the other patron of Dalbury with Long Lane having the third turn."

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 21st day of February, 1952, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parish of Saint John with Saint Mary, Devizes, the parish of Saint Peter, Devizes, and the chapelry of Saint James, Southbroom within the parish of Bishop's Cannings, all in the diocese of Salisbury.

"Whereas we are satisfied that it is desirable that

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes and of the said chapelry should be altered in the manner hereinafter

And whereas the Right Reverend William, Bishop of Salisbury, consents to the proposed arrangements (in testimony whereof he has signed this Scheme):

"Now therefore we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Saint John with Saint Mary, Devizes, and Saint Bater, Devizes, and of the said chapelry and Saint Peter, Devizes, and of the said chapelry of Saint James, Southbroom, shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

"THE SCHEDULE.

"(a) The territory to be annexed to the parish of Saint Peter, Devizes:—

"All that part (coloured pink on the map annexed hereto) of the parish of Saint John with Saint Mary, Devizes, which is bounded upon the north-west by the parish of Potterne, upon the north by the parish of Saint Peter, Devizes, and upon the remaining sides by an imaginary line com-mencing at a point on the boundary which divides the parish of Saint John with Saint Mary, Devizes, from the parish of Saint Peter, Devizes, in the from the parish of Saint Peter, Devizes, in the middle of Station Road and continuing thence southwards along the middle of Station Road for a distance of five chains and continuing thence southwards in a straight line to a point in the middle of the Devizes Branch Line of the British Railways (Western Region), and continuing thence westwards along the middle of the said railway line to the boundary which divides the parish of Saint John with Saint Mary, Devizes, from the parish of Potterne.
