"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Saint Mary, Streatham (commonly known as Saint Mary, Balham), The Ascension, Balham Hill, and Saint Luke, Battersea, all in the diocese of Southwark.

"Whereas we are satisfied that it is desirable that

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Reverend Bertram, Bishop of Southwark, consents to the proposed arrangements (in testimony whereof he has signed

arrangements (in testimony whereof he has signed this Scheme):

"Now therefore we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Saint Mary Streatham (commonly known as Saint Mary, Balham), The Ascension, Balham Hill, and Saint Luke, Battersea, shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme.

"THE SCHEDULE.

"(a) The territory to be annexed to the parish of Saint Mary, Streatham (commonly known as Saint

Mary. Balham):

"(i) All those contiguous parts of the parishes of The Ascension, Balham Hill, and Saint Luke, Battersea, which, taken together, are bounded upon the south and east by the parish of Saint Mary, Streatham, and upon the remaining Saint Mary, Streatham, and upon the remaining sides by an imaginary line commencing on the boundary which divides the parish of The Ascension, Balham Hill, from the parish of Saint Mary, Streatham, in the middle of Calbourne Road and continuing thence southwestwards along the middle of Calbourne Road to a point opposite to its southwestern end in the middle of Ravenslea Road (thereby crossing the boundary which divides the parish of The Ascension Balham Hill, from the parish of Saint Luke Battersea) and continuing parish of Saint Luke, Battersea) and continuing thence southeastwards along the middle of Ravenslea Road (thereby recrossing the lastmentioned boundary) to a point opposite the northeastern end of the wall or fence which divides the houses and premises known as Nos. 87 and 89 Ravenslea Road and continuing thence southwestwards to and along the last-mentioned wall or fence and in the same straight line to the boundary which divides the parish of The Ascension, Balham Hill, from the parish of Saint Luke, Battersea. "(ii) All that further part of the parish of The Ascension, Balham Hill, which is bounded upon the south by the parish of Saint Mary, Streatham, and upon the remaining sides by an imaginary line commencing on the boundary which divides the parish of Saint Mary, Streatham, from the parish of The Ascension, Balham Hill, in the middle of Chestnut Grove and continuing thence northwards along the middle of Chestnut Grove to a point opposite parish of Saint Luke, Battersea) and continuing

and continuing thence northwards along the middle of Chestnut Grove to a point opposite the western end of the wall or fence which divides the house and premises known as No. 114 Chestnut Grove from the house and premises known as No. 17 Nightingale Square and continuing thence eastwards to and along the lest marticipal well or fence to its end and continuing thence eastwards to and along the last-mentioned wall or fence to its end, and continuing thence southwards along the wall or fence which divides No. 114 Chestnut Grove from the house and premises known as No. 15 Nightingale Square, and in the same straight line to the boundary which divides the parish of The Ascension, Balham Hill, from the parish of Saint Mary, Streatham.

"(b) The territory to be annexed to the parish of The Ascension, Balham Hill:—

"(i) All that part of the parish of Saint Mary, Streatham, which lies to the north of the middle of Calbourne Road.

"(ii) All that part of the parish of Saint Luke, Battersea, which lies to the north of the middle of Calbourne Road, to the east of the middle of Ravenslea Road and to the south of the middle of Nightingale Lane.

"(c) The territory to be annexed to the parish

of Saint Luke, Battersea:

"All that part of the parish of The Ascension, Balham Hill, lying to the south of the middle of Ravenslea Road and not annexed in accordance with the provisions of paragraph (a) (i) of this Schedule to the parish of Saint Mary, Streatham."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and submission of this Scheme, have been duly complied

with -

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwark.
