The QUEEN's Most Excellent Majesty in Council. WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 23rd day of May, 1952, in the words and figures following, that is to say: "We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1936, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Spencer, Bishop of Peterborough (in witness whereof he has signed the Scheme), for effecting the disunion of the united benefices of Lowick and Slipton and the union of the benefice of Slipton with the benefice of Twywell all of which benefices are situate in the diocese of Peterborough. Peterborough,

" SCHEME.

"Whereas by an Order of Her late Majesty Queen Victoria in Council dated the 24th day of March, 1876, and published in the London Gazette on the 4th day of April, 1876, the benefice of Lowick and the benefice of Slipton were united into one benefice for the cure of souls:

"Now therefore, we, the said Church Commissioners, do humbly recommend and propose to Your Majesty as follows, that is to say:—

- "(1) Disunion of the united benefices of Lowick and
- "(1) The union of the benefice of Lowick and the benefice of Slipton shall be dissolved and the said benefices of Lowick and Slipton shall thereupon each become a separate benefice with cure of souls within
- become a separate benefice with cure of souls within the limits of its separate parish.

 "(2) The disunion of the said united benefices shall take effect upon the day when any Order of Your Majesty in Council affirming the Scheme is published in the London Gazette and the Reverend Percival William Worster if he is then incumbent of the said united benefices shall with his consent (testified by his signature hereto) be the first incumbent of the separate benefice of Lowick.

 "(3) The passoness house at Lowick of the said
- "(3) The parsonage house at Lowick of the said united benefice shall belong to the benefice of
- Lowick.

 "(4) The liability for the repayment to us, the said Church Commissioners, of the principal sums of £62 and £50, each together with interest, which by two deeds each dated the first day of September, 1947, is charged upon the endowments and emoluments of the benefice of Lowick with Slipton shall attach solely to the endowments and emoluments of the benefice of Lowick, and the emoluments of the benefice of Slipton shall stand discharged from any portion of the said liability.

- "(5) The endowments and property of the said united benefice shall be divided and distributed as follows, that is to say, the endowments and property specified in Part I of the Schedule hereto shall be assigned and annexed to the benefice of Slipton and the endowments and property specified in Part II of the said Schedule shall be assigned and annexed to the benefice of Lowick.
- 2. Union of the benefices of Twywell and Slipton.

"(1) The benefice of Twywell and the benefice of

"(1) The benefice of Twywell and the benefice of Slipton shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Twywell with Slipton', but the parishes of the said benefices shall continue in all respects distinct.

"(2) The union shall take effect upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette and the Reverend Sydney James Glenn if he is then incumbent of the said benefice of Twywell shall with his consent (testified by his signature hereto), be the first incumbent of the united benefice of

with his consent (testified by his signature hereto), be the first incumbent of the united benefice of Twywell with Slipton.

"(3) Upon the union taking effect the parsonage house at present belonging to the benefice of Twywell shall be the house of residence of the incumbent of the united benefice.

"(4) After the union has taken effect the rich.

"(4) After the union has taken effect the right of presentation to the united benefice shall be exercised by the patron of the two benefices alternately, the patron of the benefice of Twywell having the first turn.

"THE SCHEDULE.

" Part I.

"(Endowments and property of the united benefice of Lowick with Slipton to be assigned and annexed to the benefice of Slipton upon the disunion taking effect).

"A sum of £5,662 18s. 1d. capital held by the Church Commissioners and producing an income of £211 per annum.

"Part II.

- "(Endowments and property of the united benefice of Lowick with Slipton to be assigned and annexed to the benefice of Lowick upon the disunion taking effect).
- "1. A sum of £9,459 13s. 0d. capital held by the Church Commissioners and producing an income of

£352 9s. 4d. per annum.

"2. All other the endowments and property of the united benefice not mentioned in Part I of this Schedule." Schedule.

And whereas the provisions of the Union of Benefices Measures, 1923 to 1936, and the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:
