Now, therefore, Her Majesty, in pursuance of the powers vested in Her by the aforesaid section and of all other powers enabling Her in that behalf, by and with the advice of Her Privy Council, is pleased to order and doth hereby order as follows:—

1. It is hereby declared that the Government of Israel has acceded to the Safety Convention.

2. This Order may be cited as the Merchant Shipping (Safety Convention) (Israel) Order, 1952.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 26th day of August, 1952, in the words and figures following, that is to say:—
"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty

in Council the following Scheme for altering the boundaries of the parishes of Christ Church, Cobridge, and Northwood both in the diocese of Lichfield and for constituting a new parish to be taken out of the parish of Christ Church, Cobridge.

"Whereas we, the Church Commissioners, are satisfied (1) that it is desirable that the boundaries of the parish of Christ Church, Cobridge, and of the parish of Northwood should be altered in the manner described in Part I of the subjoined Schedule and as delineated on the map hereto annexed and (2) that the spiritual interests of the area defined in Part II of the said Schedule and delineated on the said map would be best served by constituting it a new parish and that a suitable endowment therefor will be provided:

"And whereas we have not approved any con"the the area described in Part II secrated church within the area described in Part II of the said Schedule as suitable to be the parish

of the said Schedule as suitable to be the parish church of the new parish.

"Now, therefore, with the consent of the Right Reverend Edward, Bishop of Lichfield (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

"I. As from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council confirming this Scheme, the boundaries of the said parish of Christ Church, Cobridge, and of the said parish of Northwood shall be altered in the manner described in Part I of the said Schedule and delineated on the said map.

"2.—(a) As from the date of the licence thereto of a minister the area defined in Part II of the said Schedule and delineated on the said map shall be a separate district for spiritual purposes.

"(b) As from the date of the consecration of a church within the said area approved by us, the said Church Commissioners, as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said

area shall become a new parish.

"(c) The name of the district (or parish as the case may be) shall be 'the District (or Parish) of Saint Andrew, Sneyd Green'.

"(d) The district (or parish) shall be in the archdeaconry of Stoke on Trent and in the rural deanery of Stoke on Trent.

"THE SCHEDULE.

Part I.

"The territory (shown by the blue colour on the map) to be annexed to the parish of Northwood:—
"All that part of the parish of Christ Church, Cobridge, which is bounded on the east by the parishes of Saint Philip and Saint James, Milton, and Bucknall cum Bagnall, on the southwest by the said parish of Northwood and upon the remaining side by an imaginary line commencing at a point on the boundary which divides the said
