DISEASES OF ANIMALS ACT, 1950.

Notice is hereby given in pursuance of Section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture and Fisheries has made the following Order:—

Statutory Instruments 1952, No. 1933.

*The Diseases of Animals (Therapeutic Substances)
Order, 1952*

(Made 6th November, 1952.)

This Order, which comes into operation on 1st January, 1953, prohibits except under licence the manufacture for sale or the landing in Great Britain of vaccines, sera, antitoxins and antigens intended to be used solely for veterinary purposes. It prescribes the standard of purity applicable to these substances and tests for determining whether that standard has been attained. It revokes the Diseases of Animals (Importation of Therapeutic Substances) Order of 1936 (S.R. & O. 1936, No. 515).
