

moral or social welfare of the parishioners of the united parish of Saint Peter the Great, Chichester, and others or either exclusively or in conjunction with any such purposes as aforesaid for use or occupation by any diocesan body or organisation or otherwise for the furtherance of the work of the Church of England or the administration of its affairs and such appropriation shall be subject to such conditions, regulations and provisions as the Bishop of Chichester shall by Deed made pursuant to the 24th Section of the Union of Benefices Measure, 1923, declare and appoint.

"5. *Registers.* The marriage registers current at the churches of Saint Olave, Chichester; Saint Andrew, Chichester; Saint Peter the Less, Chichester; and All Saints, Chichester, shall be dealt with in accordance with Section 62 of the Marriage Act, 1949, and the register books (if any) of baptisms and burials and other the records and muniments deposited in the said churches shall be transferred to the parish church of Saint Peter the Great, Chichester.

"6. *Patronage.* With the consents of the Right Honourable Gavin Turnbull, Baron Simonds, now Lord High Chancellor of Great Britain, acting on behalf of Her Majesty as patron of the said benefice of Chichester, Saint Peter the Less, the Right Honourable and Most Reverend Geoffrey, Archbishop of Canterbury, being the patron of the said benefice of Chichester, All Saints, and of the Dean and Chapter of the Cathedral Church of the Holy Trinity, Chichester (hereinafter called 'the Dean and Chapter') being the patrons of the said benefices of Chichester, Saint Olave with Saint Martin; Chichester, Saint Andrew; and Chichester, Saint Peter the Great (in testimony whereof they have respectively executed this Scheme) the patronage of the said benefice of Chichester, Saint Peter the Less, and of the said benefice of Chichester, All Saints, shall be surrendered in favour of the Dean and Chapter and the patronage of the said united benefice shall belong wholly to the Dean and Chapter.

"7. *Diversion of Endowments.* Upon the union taking effect a part of the endowments of the united benefice, namely, sums of (i) £2,000 £2½ per cent. Treasury Stock (1975-) now held by us on behalf of the benefice of Chichester, Saint Andrew, and (ii) £1,600 £2½ per cent. Treasury Stock (1975-) now held by us on behalf of the benefice of Chichester, Saint Olave with Saint Martin, or such sum of money as may have been appropriated by us to the united benefice pursuant to the Benefices (Stabilization of Incomes) Measure, 1951, in respect of the said endowments, shall with the consent of the Dean and Chapter (testified as aforesaid) be severed or diverted from the said benefices of Chichester, Saint Andrew, and Chichester, Saint Olave with Saint Martin, and from the united benefice and shall be appropriated and held by us for the augmentation of the benefice of Rumboldswyke in the said diocese of Chichester and the income arising from the said endowments shall be used by the incumbent of the said benefice of Rumboldswyke solely towards the remuneration of a whole-time assistant curate serving in the parish of the said benefice of Rumboldswyke or of such other clerical or lay assistance in the said parish as the Bishop of Chichester for the time being shall from time to time direct.

"*Alteration of Parochial Boundaries.* The boundaries of the parishes of Saint Bartholomew, Chichester; Saint Paul, Chichester, Saint Peter the Great, Chichester; Saint Peter the Less, Chichester; Saint Pancras, Chichester; Rumboldswyke; Portfield; and Saint Andrew, Chichester, shall, with the consents (testified by their signature hereto) of the Reverend Cecil Ernest Rycart, being the incumbent of the said benefice of Saint Bartholomew, Chichester, of the Reverend Charles Godfrey Platt Wells, being the incumbent of the said benefice of Saint Peter the Great, Chichester, of the Reverend Harry Watson, being the incumbent of the said benefice of Saint Pancras, Chichester, of the Reverend Richard Charles Ratcliff, being the incumbent of the said benefice of Rumboldswyke, of the Reverend Robert Edward Davison Hull, being the Incumbent of the said benefice of Portfield, and of the Reverend Charles Binstead Fowler, being the incumbent of the said benefice of Saint Paul, Chichester, be altered in the manner described in the Schedule to this Scheme.

"THE SCHEDULE.

"1. The territory, shown by the green colour on the map to be annexed to the parish of Saint Bartholomew, Chichester:—

"(a) All that part of the parish of Saint Paul, Chichester, which is bounded on part of the south by the parish of Fishbourne, the remaining part of the south and on the east by the parish of Saint Bartholomew, Chichester, and on the remaining sides by an imaginary line commencing on the boundary which divides the parish of Saint Bartholomew, Chichester, from the parish of Saint Paul, Chichester, at a point at the south eastern end of the wall or fence which forms the south western boundary of the house and premises known as number 64 Parklands Road and continuing thence north westwards along the said wall or fence to a point opposite to its north western end in the middle of Parklands Road and continuing thence south westwards along the middle of Parklands Road to a point opposite to the middle of the south eastern end of Cedar Close and continuing thence north westwards along the middle of Cedar Close to a point in the middle of Cedar Drive and continuing thence in a straight line to the south eastern end of the wall or fence which forms the south western boundary of the house and premises known as number 50 Cedar Drive and continuing thence north westwards along the last mentioned wall or fence to its north western end and continuing thence north westwards in a straight line to the middle of the bridge which carries the Chichester and Midhurst Branch Line of British Railways (Southern Region) over Salthill Lane and continuing thence south westwards along the middle of the said railway line to the boundary which divides the parish of Saint Paul, Chichester, from the parish of Fishbourne.

"(b) All that part of the parish of Saint Paul, Chichester, which lies to the south of an imaginary line commencing on the boundary which divides the parish of Saint Paul, Chichester, from the parish of Saint Peter the Great, Chichester, at a point at the south eastern end of the walls or fences which form the south western boundary of the houses and premises known as numbers 56, 58, 60 and 62 Orchard Street and extending thence north westwards along the last-mentioned wall or fence to its north western end on the boundary which divides the parish of Saint Paul, Chichester, from the parish of Saint Bartholomew, Chichester.

"(c) All that detached part of the parish of All Saints, Chichester, adjacent to the south east corner of the parish of Saint Bartholomew, Chichester, and bounded on the north east and south by the parish of Saint Peter the Great, Chichester.

"(d) All that part of the parish of Saint Peter the Great, Chichester, which lies to the south of the middle of the Main Line of British Railways (Southern Region) and which is not annexed to the parish of Rumboldswyke by the succeeding provisions of this Scheme.

"2. The territory shown by the yellow colour on the map to be annexed to the parish of Saint Paul, Chichester:—

"(a) All that part of the parish of Saint Bartholomew, Chichester, which is bounded on the north east and south east by the parish of Saint Paul, Chichester, and on the remaining side by an imaginary line commencing on the boundary which divides the parish of Saint Paul, Chichester, from the parish of Saint Bartholomew, Chichester, at a point in the middle of Orchard Street opposite to the middle of the southern end of the track or footpath known as Orchard Path and continuing thence northwards first to and then along the middle of the said track or footpath to the boundary which divides the parish of Saint Bartholomew, Chichester, from the parish of Saint Paul, Chichester.

"(b) All that part of the parish of Saint Bartholomew, Chichester, which is bounded on the north, east and south by the parish of Saint Paul, Chichester, and lies to the south east of the track or footpath known as Orchard Path.

"(c) All that detached part of the parish of Saint Peter the Less, Chichester, lying to the south west of the intersection of Wellington Road and Broyle Road and in the middle of the parish of Saint Paul, Chichester.

"(d) All that detached part of the parish of Saint Peter the Great, Chichester, being the churchyard surrounding the church of Saint Paul, Chichester.
