RECRUITMENT OF VEHICLE EXAMINERS IN THE MINISTRY OF TRANSPORT.

1. Age
Candidates must have been born on or before 1st
January, 1923. The Commissioners have not specified

an upper age limit for this Competition. In general, however, Government Departments require a reasonable period of service from persons newly appointed to the Civil Service; and accordingly the Commissioners reserve the right to give weight to this factor in considering candidates for these posts who are over 50 years of age.

2. Sex and Marriage
(i) Both men and women may compete under these

Regulations.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before or who are separated from their husbands, or whose busbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid.

Provided that this undertaking will not be required if the break between the first period of service (including any period of unestablished service immediately following the period in respect of which the gratuity was paid) and the date of re-establishment is more than seven years.

3. Nationality

(b) If naturalised British subjects they must have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment.

(c) If not qualified under (a) or (b) of this paragraph they must satisfy the Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

4. Qualifications
Candidates must be first-class motor mechanics and have had a good comprehensive training and a minimum of three years' practical experience beyond the apprenticeship stage with a reputable firm of motor engineers, or public authority, or have had equivalent experience in the Armed Forces. They should have good practical experience of the construction and repair of chassis and bodies of both goods and public service vehicles, and of driving such vehicles. They should know the Highway Code in detail. They must be capable of working without immediate supervision and able to write reports in a clear and concise manner.

The possession of a Higher National Certificate in Mechanical Engineering or evidence of an equivalent standard of technical education or specialist qualification will be an advantage.
