WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 20th day of November, 1952, in the words and figures following, that is

"We, the Church Commissioners, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, and the Pastoral Reorganisation Measure, 1949, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Russell, Bishop of Southwell (in witness whereof he has signed the Scheme), for effecting the union of the benefice of North Leverton and the benefice of South Leverton both situate in the diocese of Southwell.

"Whereas the said benefices of North Leverton and South Leverton are now held in plurality by the Reverend Reginald John Wagstaff:

"Now, therefore, we, the said Church Commissioners, do humbly recommend and propose to Your Majesty as follows, that is to say:—

" SCHEME.

"1. Union of Benefices. The benefice of North Leverton and the benefice of South Leverton shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of North and South Leverton', but the parishes of the said benefices shall continue in all respects distinct

"2. Taking effect of Union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect, and the said Reginald John Wagstaff if he is then incumbent of both of the said benefices of North Leverton and South Leverton shall, with his consent (testified by his signature hereto), be the first incumbent of the united benefice and his admission thereto shall be without any form or fee of or for presentation or nomination and he shall not be required to pay any fees in respect of his collation, institution, licence or induction to the united benefice beyond such fees fees in respect of his collation, institution, licence or induction to the united benefice beyond such fees as he would have been liable to pay if his admission to the united benefice had been an admission solely to that one of the said two benefices for the holding of which in plurality with the other a Dispensation was heretofore granted to him."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1936, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to

affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Ripley and Saint James, Birstwith, both in the diocese of Ripon.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

"And whereas the Right Revered George Rishop.

"And whereas the Right Reverend George, Bishop of Ripon, consents to the proposed arrangements (in testimony whereof he has signed this Scheme):

"Now, therefore, we, the said Church Commissioners, humbly recommend and propose that from and after the day of the date of publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme the boundaries of the said parishes of Ripley and Saint James, Birstwith, shall be altered in the manner described in the Schedule and delineated on the map annexed to this Scheme. annexed to this Scheme.

"THE SCHEDULE.

"The territory, shown by the pink colour on the map, to be annexed to the parish of Saint James,

map, to be annexed to the parish of Saint James, Birstwith:—

"All that part of the parish of Ripley which is bounded on the southwest by the parishes of Hampsthwaite and Saint James, Birstwith, on the northwest in part by the parish of Saint James, Birstwith, and on the remaining part by the parish of Hartwith-cum-Winsley and on the remaining sides by an imaginary line commencing at a point on the boundary which divides the parish of Hartwith-cum-Winsley from the parish of Ripley at the northwestern end of the wall or fence which divides close numbered 253 on the map from close numbered 254 and extending thence generally southeastwards along the said wall or fence and along the walls or fences which divide closes numbered 251, 221, 148 and 150 to their junction with the wall or fence which divides closes numbered 220 and 150 from close numbered 152 and continuing thence southeastwards in a straight and continuing thence southeastwards in a straight line to the northwestern end of the wall or fence
