

"5. *Patronage.* With the consents of the President and Scholars of Saint John Baptist College in the University of Oxford, being the patrons of the benefice of Aston le Walls, and of the Master Fellows and Scholars of Emmanuel College in the University of Cambridge, being the patrons of the benefice of Boddington (in testimony whereof the respective patrons have executed this Scheme), the patronage of the said benefice of Aston le Walls shall be surrendered in favour of the said Master Fellows and Scholars of Emmanuel College in the University of Cambridge, and the patronage of the united benefice shall belong wholly to the said Master Fellows and Scholars of Emmanuel College in the University of Cambridge."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this scheme have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.
