WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 26th day of March, 1953, in the words and figures following, that is to say: "We, the Church Commissioners, acting in pursuance of the Union of Benefices Measures, 1923 to 1952, and the Pastoral Reorganisation Measure, 1949, now humbly lay before Your Majesty in Council the following Scheme which we have pre-pared with the consent of the Right Reverend Thomas, Bishop of Carlisle (in witness whereof he has signed the Scheme) for effecting the union of the benefice of Westward and the benefice of Rosley-with-Woodside both situate in the diocese of Carlisle. "SCHEME

#### " SCHEME

"SCHEME "1. Union of Benefices. The benefice of West-ward and the benefice of Rosley-with-Woodside shall be permanently united together and form one bene-fice with cure of souls under the style of 'The United Benefice of Westward and Rosley-with-Woodside', but the parishes of the said benefices shall continue in all respects distinct. "2. Taking effect of union. Upon the day when any Order of Your Majesty in Council ratifying this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Thomas Railton Harper if he is then incumbent of the said benefice of Rosley-with-Woodside shall with his consent (testified by his signature hereto) be the first incumbent of the united benefice. "3. Parsonage House. Without prejudice to the exercise, before the date when the union takes effect, of any of the powers conferred by the Parsonages

exercise, before the date when the union takes effect, of any of the powers conferred by the Parsonages Measures, 1938 and 1947, the parsonage house at present belonging to the benefice of Rosley-with-Woodside shall, if at that date it belongs to the said benefice, be the house of residence of the incumbent of the united benefice, and the parsonage house at present belonging to the benefice of Westward, if at that date it so belongs, and the site and appurten-ances thereof and the grounds heretofore usually occupied and enjoyed therewith shall, as soon as conveniently may be, be sold and disposed of by us, the said Church Commissioners, at such time or times and in such manner in all respects as to us shall seem expedient, and the net proceeds of such sale or sales shall be appropriated and held by us for sale or sales shall be appropriated and held by us for the augmentation of the endowment of the united benefice.

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the pre-paration and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.
