RIVER BOARDS ACT, 1948.

*Lancashire River Board Area.*

In pursuance of subsection (3) of Section 6 of the River Boards Act, 1948, the Minister of Agriculture and Fisheries hereby gives notice that the Lancashire River Board have made application under the said subsection that the map approved under subsection (2) of the said Section showing the extent of the main river for the purposes of Part II of the Land Drainage Act, 1930, be varied by the deletion from the said main river of the following watercourses:—

1. The disused Mill Race from the site of the old weir on the River Calder near Billington through Bobbin Mill to its confluence with the River Calder. Length approximately 830 yards.

2. Approximately 670 yards of the Black Brook measured from its confluence with Bullens Brook near Scarisbrick in a North-Westerly direction.

Plans on which the proposed variations are shown have been deposited for public inspection at the following addresses for a period of thirty-five days from the date of this Notice and may be inspected during normal office hours:—

*Mill Race*—at the offices of the Rural District Council of Clitheroe, Church Brow, Clitheroe, Lancs.

*Black Brook*—at the office of the River Crossens Drainage Board, 24, Hoghton Street, Southport, Lancs.

Copies of both plans have also been deposited at the offices of the Ministry of Agriculture and Fisheries, Someries House, St. Andrew's Place, Regent's Park, London, N.W.1. A copy of the statutory map of the River Board Area on which is shown existing main river may also be seen at this address and at the offices of the Lancashire River Board, 48, West Cliff, Preston, Lancs.

Any objection to the proposed variations of the statutory map should be made in writing and sent by post, addressed to the Secretary, Ministry of Agriculture and Fisheries, at the address mentioned below within thirty-five days from the date of this notice quoting reference LDC 423.
