RATES OF INTEREST ON LOCAL LOANS. NOTICE.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that in pursuance of the powers conferred on Them by the Public Works Loans Act, 1897 (60 and 61 Vict. c. 51) as amended by the Public Works Loans Act, 1917 (7 and 8 Geo. 5 c. 32), the Public Works Loans Act, 1918 (8 and 9 Geo. 5 c. 27), the Housing Act, 1936 (26 Geo. 5 and 1 Edw. 8 c. 51) as amended by the Public Works Loans (No. 2) Act, 1946 (9 and 10 Geo. 6 c. 75), and the Housing (Scotland) Act, 1925 (15 Geo. 5 c. 15) as amended by the Housing (Scotland) Act, 1935 (25 and 26 Geo. 5 c. 41), They have directed by Their Minute of the 19th October, 1953, that on loans advanced otherwise than on the security of local rates from the Local Loans Fund, on and after the 20th October, 1953, there shall be chargeable in the 20th October, 1953, there shall be chargeable in lieu of the rates fixed by the Treasury Minute of the 8th February, 1952, the following rates of interest:

Loans to housing associations as defined by the Housing Act, 1936, and the Housing (Scotland) Act,

For any period up to 50 years, 4 per cent.

Loans under the Housing Acts to companies and private persons, limiting their profits to the rate for the time being prescribed:

For any period up to 40 years, 4 per cent.

Loans under the Housing Acts to companies and private persons not limiting their profits as aforesaid:

For any period up to 40 years, 41 per cent.

Loans under the Harbours and Passing Tolls, etc., Act, 1861, with collateral security:

For any period up to 50 years, 4 per cent.

Loans under the Harbours and Passing Tolls, etc., Act, 1861, without collateral security:

For any period up to 50 years, 44 per cent.

All other Loans: For any period, 44 per cent. Treasury Chambers. 19th October, 1953.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that in pursuance of the powers conferred on Them by the Public Works Loans Act, 1897 (60 and 61 Vict. c. 51) They have directed by Their Minute of the 19th October, 1953, that on loans advanced to Local Authorities from the Local Loans Fund, on and after the 20th October, 1953, there shall be chargeable in lieu of the rates fixed by the Treasury Minute of the 8th February, 1952, the following rates of interest:—

Loans for not more than five years, 24 per cent. Loans for more than five years but not more than fifteen years, 3½ per cent.

Loans for more than fifteen years, 4 per cent.
