1. Any person proposing to provide or procure the provision of additional production facilities in Great Britain the cost of the provision of which is estimated to exceed £100,000 shall give particulars in writing of the proposal to the Board and shall not proceed therewith without the consent in writing of the Board.

2. This notice shall not apply to any proposal to provide or secure the provision of additional production facilities consisting only of premises, plant or machinery proposed to be used for the carrying on of any activity mentioned in Section 6 (6) of the Act nor to any provision of additional production facilities pursuant to Section 5 (3) of the Act.

3. In this notice "production facilities" and "additional production facilities" shall have the meanings attached thereto by section 34 of the Act.
