## TOWN AND COUNTRY PLANNING ACT, 1947.

The Minister of Transport and Civil Aviation hereby gives notice that he has made an Order under s. 49 of the Town and Country Planning Act, 1947, entitled "The Stopping up of Highways (Middlesex) (No. 5) Order, 1953" authorising the stopping up of a length of Seymour Gardens, Twickenham, Middlesex, and requiring the provision of a new road.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Town and Country Planning Act, 1947, or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 4th December, 1953, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

## SPECIAL ROADS ACT, 1949.

### *Church Street, Briton Ferry, Improvements.*

The Minister of Transport and Civil Aviation hereby gives notice that he proposes to make an Order under section 14 of the Special Roads Act, 1949, the effect of which will be:—

(a) to provide for the improvement of Church Street, Briton Ferry, in the Borough of Neath by realigning a length of the carriageway;

(b) to provide for the stopping up of a part of Church Street, Briton Ferry.

Copies of the draft Order and the plan showing the proposed improvements and the part of Church Street to be stopped up may be inspected free of charge at all reasonable hours from 4th December, 1953, to 5th March, 1954, at the Ministry of Transport and Civil Aviation, 21-37, Hereford Road, London, W.2, at the office of the Neath Borough Council, Municipal Buildings, Neath, or at the offices of the Divisional Road Engineer, Graham Buildings, Newport Road, Cardiff.

## DISEASES OF ANIMALS ACT, 1950.

Notice is hereby given in pursuance of section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture and Fisheries has made the following Order:—

Statutory Instruments 1953 No. 1751.

*The Foot-and-Mouth Disease (Infected Areas) Special Order No. 38, 1953.*

(Made 30th November, 1953.)

1. Declares an area comprising the districts situate within approximately 15 miles of Cadoxton, Neath, Glamorgan, to be an Infected Area for the purpose of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the counties of Brecknock, Carmarthen and Glamorgan.

2. Permits pigs to be sent to a slaughterhouse or bacon-factory in the Infected Area with a licence

issued by an Inspector of the Local Authority for the district from which the pigs are moved. Licences issued under this Order do not require countersignature and may be granted only on production of a Ministry of Food delivery advice note.

3. Revokes Special Order No. 35, 1953, and Articles 2 and 3 of Special Order No. 37, 1953.
