UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923.

A Statute made by the Governing Body of Worcester College, in the University of Oxford, on the 6th November, 1953, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of The Universities of Oxford and Cambridge Act, 1923.

THE Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Sections 3 and 19 of the Import Duties Act, 1932, and Section 1 of the Import Duties (Emergency Provisions) Act, 1939, viz.:

The Additional Import Duties (No. 4) Order, 1953, which alters the rate of duty chargeable under the Import Duties Act, 1932, on dried peas of the kind specified, from 10 per cent. ad valorem to 7s. 6d. per cwt. when the value does not exceed £3 15s. 0d. per cwt.

The Order comes into operation on the 9th December, 1953, and has been published as Statutory Instruments 1953, No. 1760.
