Declares an area comprising the districts situate within approximately 15 miles of Tir Phil, Bargoed, Glamorgan, to be an Infected Area for the purpose of preventing the spreading of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The area subject to restrictions lies in the counties of Brecknock, Glamorgan and Monmouth.

2. Permits pigs to be sent to a slaughterhouse or bacon-factory in the Infected Area with a licence issued by an Inspector of the Local Authority for the district from which the pigs are moved. Licences issued under this Order do not require countersignature and may be granted only on production of a Ministry of Food delivery advice note.
