*Westminster, 26th March, 1954.*

This day, the Lords being met, a message was sent to the Honourable House of Commons, by the Gentleman Usher of the Black Rod, acquainting them that *The Lords authorised by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to the Acts agreed upon by both Houses, to desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read,* and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to:—

Consolidated Fund Act, 1954.  
Hill Farming Act, 1954.  
Northern Assurance Act, 1954.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under section 10 of the Finance Act, 1926, exempting the following articles from Key Industry Duty for a period ending with the 18th August, 1954.

Scientific glassware, the following:—

Tubing of neutral glass, not being coloured or borosilicate glass, in straight lengths having an external diameter of not less than 8 millimetres and not more than 35 millimetres and a wall thickness of not less than 0.3 millimetres and not more than 1.5 millimetres, and being capable of passing a test corresponding with the test for limit of alkalinity of glass prescribed by British Pharmacopoeia, 1953.

Synthetic organic chemicals, analytical reagents, other fine chemicals and chemicals manufactured by fermentation processes, the following:—

*tert*Amyl alcohol.  
3-*tert*Butyl-2:6-dinitro-4-isopropyltoluene (a nitrobutyltoluene homologue).  
2:6-Diaminopyridine (an aminopyridine).  
Diethyl 4-methyl-2-isopropyl-6-pyrimidyl thionophosphate (an ethyl ester).  
Ethylene glycol monobutyl ether (an ethylene glycol ether).  
*mono*Fluorobenzene.  
Lithium carbonate.  
Phosphorus pentasulphide containing not more than 0.06 per cent. by weight of material insoluble in 6N ammonia solution.  
Sodium 2:4:5-trichlorophenoxide.

The Order which comes into operation on the 1st April, 1954, is entitled the Safeguarding of Industries (Exemption) (No. 3) Order, 1954, and is published as Statutory Instruments, 1954, No. 388.
