The Import Duties (Drawback) (No. 3) Order, 1954, which reduces from 70s, to 60s. per cwt. the rate of drawback of customs duty allowable in respect of imported chewing gum base used in the manufacture of chewing gum or chewing sweets which are exported or shipped as stores.
