##### HEANOR URBAN DISTRICT COUNCIL.

##### *Aldercar Footpath Diversion Order, 1954.*

NOTICE is hereby given that on the 22nd day of May, 1954, the Minister of Housing and Local Government confirmed with modifications the above Order.

The Order relates to land situate at Aldercar in the East Ward of the Urban District of Heanor.

The effect of the Order is to divert the greater part of the public right of way running from Upper Dunstead Road in a north westerly direction for a distance of approximately 1,750 feet to Cromford Road, to a line running from Upper Dunstead Road in a northerly direction through Dunstead Road Recreation Ground for a distance of 550 feet along the causeways of Greenfields and of a new street known as Daltons Close for a distance of 750 feet and thence by a new footpath in a northerly direction for a distance of 375 feet to a new junction with Cromford Road. The path to be diverted will be closed at the expiration of twenty-one days from the date of confirmation of this Order.

The Order becomes operative as from the 3rd day of June, 1954, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the National Parks and Access to the Countryside Act, 1949, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice make application to the High Court.
