

(b) a rate equal to the difference between £5 a week or, in the case of a woman, £4 a week, and the rate of any National Insurance benefit to which the member may be entitled, so, however, that no account shall be taken of any increase in the rate of such benefit in respect of children or adult dependants under section twenty-three or twenty-four of the National Insurance Act, 1946, or under section seventeen or eighteen of the National Insurance (Industrial Injuries) Act, 1946.

(2) In relation to a period of less than a week, including such a period at the end of a period of completed weeks, sub-paragraph (b) of the preceding paragraph shall have effect as if for the reference therein to the weekly rates of £5 and £4 there were substituted a reference to the daily rates of 16s. 8d. and 13s. 4d. respectively.

3.—(1) In this Warrant—

"Civil Defence Corps" means the Corps established by and under the warrant of the Secretary of State intituled the Civil Defence Corps Warrant, 1949, and any subsequent warrants of the Secretary of State amending it and from time to time in force;

"National Insurance Benefit" means any of the following benefits, that is to say:—

(a) sickness benefit under the National Insurance Act, 1946 and

(b) injury benefit under the National Insurance (Industrial Injuries) Act, 1946.

(2) In this Warrant a reference to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

4. This Warrant shall come into operation on the 9th day of July, 1954.
