

4. To enact all necessary provisions for giving full effect to the purposes of the Order and to vary or extinguish all rights, powers and privileges inconsistent therewith.

And notice is hereby also given as follows:—

(a) Every company, body or person desirous of making any representation to the Minister of Transport and Civil Aviation or of bringing before him any objection respecting the application may do so by letter addressed to the Secretary, Ministry of Transport and Civil Aviation, Berkeley Square (House, London, W.1, on or before the 15th January, 1955. Copies of such objections must at the same time be sent to the under-mentioned Town Clerk or Parliamentary Agents and in forwarding to the Ministry of Transport and Civil Aviation such objections, the objectors or their Agents should state that a copy of the same has been sent to the Corporation or their Agents.

(b) Printed copies of the draft Provisional Order when deposited and of the Provisional Order when made can be seen or purchased at a price of

one shilling per copy at the office of the under-mentioned Town Clerk, and such printed copies can also be purchased at the offices of the under-mentioned Parliamentary Agents.

(c) On and after the 30th day of November, 1954, a map of the district with the proposed trolley vehicle routes marked thereon and showing the width and gradient of the carriageway at all material points along each route and the narrowest widths and steepest gradients, together with a diagram showing the proposed routes in relation to existing railways, tramways or trolley vehicle routes in the immediate vicinity, can also be inspected at all reasonable hours at the office of the under-mentioned Town Clerk.

NATIONAL PARKS AND ACCESS TO THE COUNTRYSIDE ACT, 1949

COUNTY OF EAST SUFFOLK

NOTICE is hereby given that the East Suffolk County Council, in exercise of the powers conferred upon them by sub-section 3 of Section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the Draft Rights of Way Maps and Statements prepared under Section 27 of the above-mentioned Act in relation to the rights of way within the Rural Districts of Blyth, Wainford, and Samford, in the said County, by

- (i) the deletion of the footpaths indicated in the First Schedule hereto;
- (ii) the inclusion of the footpaths indicated in the Second Schedule hereto.

Maps showing these modifications have been deposited at the offices of the County Surveyor, County Hall, Ipswich, and as regards the Blyth Rural District and the Wainford Rural District, at the District Council Offices, Rendham Road, Saxmundham, and 1 Ballygate, Beccles, respectively, and may be seen there free of charge between the hours of 9 a.m. and 1 p.m., and 2.15 p.m. and 5 p.m. on Mondays to Fridays, and 9 a.m. to 12 noon on Saturdays.

Any representation or objection with regard to these determinations shall be made in writing, addressed to the Clerk of the County Council, County Hall, Ipswich, before the 10th day of December, 1954, and shall state the grounds on which it is made.

FIRST SCHEDULE

Footpaths to be deleted

<i>Rural District of Blyth</i>	
Aldringham 68 ...	From the Aldringham cross-roads in an easterly direction to Elm Tree Farm.
Aldringham 69 ...	Begins north of the Aldringham cross-roads and travels eastwards and to south of Elm Tree Farm, then north-eastwards and north to a keeper's cottage east of Aldringham House.
Blythburgh 6 ...	From the Blythburgh-Beccles Road near Tollgate Cottages, westwards skirting the bottom of Broom Covert, and then north-westwards to join the Blythburgh-Blyford Road.
Blythburgh 17 (part)...	North of the Church, along the river bank in a westerly direction as far as the bridge.
Blythburgh 18 (part)...	From the bridge west of the Bulcamp Institution, following the north bank of the river in a westerly direction as far as the Parish boundary with Blyford.
Blythburgh 12 ...	From Five Crossways at Hinton Walks, Westleton, in a general easterly direction through Fen Covert and along the marshes to the Wind Pump near Old Town Marshes.
Walberswick 35 ...	
Westleton 5 ...	
Blythburgh 9A (B.R.)	From the Blythburgh-Walberswick Road at a point opposite the private drive to Blythburgh Lodge in a north-westerly direction to join Lodge Lane.
Blythburgh 10 ...	Cuts off the north-east corner of the cross-roads near Stone Cottages and continues southwards from the Blythburgh-Walberswick Road to meet the road from Walberswick to Blythburgh Lodge near New Delight Covert.
Blythburgh 14 ...	(a) The first section begins on the Blythburgh-Westleton Road near the site of Lump Hall and travels in a westerly direction to the Wenhaston-Hinton Road; (b) The second section starts on the Wenhaston-Hinton Road approximately 440 yards south-east of Butcher's Farm and travels south-easterly to the county road through Hinton Walks.
Blythburgh 15A ...	From just south of Hinton Round Spring to Hinton Hall.
Blythburgh 16 ...	From the Blythburgh-Walberswick Road to the west of Toby's Barn, running southwards to a point north of Hinton Lodge.
Bramfield 4 ...	From north of Kingstall Wood to the Bramfield-Walpole Road.
Dunwich 15 (part) ...	From the road near Hangman's Cottages in a north-easterly direction along part of the carriageway to Scott's Hall, past the Hall, and then eastwards along Sheepwash Lane to Coney Hill at Minsmere Haven.
Westleton 21 ...	
Friston 1A (B.R.) ...	From the Saxmundham-Aldeburgh Road travelling south-west past Clump Cottages to near Marsh Cottages.
Friston 5 ...	From the Friston-Leiston Road north of Drane's Lane Cottages, travelling in a south-easterly direction as far as Five Acre Pickle.
Friston 15 (part) ...	From the Friston-Sternfield Road to Moor Farm.
Friston 24 ...	From south corner of Friston House Wood, 150 yards eastwards to the Sternfield-Aldeburgh Road.
Huntingfield 19 ...	From the Cratfield-Huntingfield Road south of Low Farm, westwards to east of Dunnett's Farm.
Knodishall 5 ...	From the Knodishall-Friston Road near "Homeward," south of St. Mary's Church, southwards.
Knodishall 1 (part) ...	Starting at the driveway to Bull's Hall on the Friston-Leiston Road, proceeding via Bull's Hall, northwards to the south-eastern corner of Watch Walk Whin.
Knodishall 21 ...	
Knodishall 22 ...	From the Leiston-Friston Road near Park Farm Cottages in a north-westerly direction to opposite the Chequers Inn, on the Sternfield-Friston-Aldeburgh Road.
Knodishall 23 ...	From the Leiston-Friston Road, south of Park Farm cottages in a north-westerly direction.
Knodishall 24 ...	Joins Footpath No. 23 a few yards from the road and travels in a westerly direction to meet the Friston-Sternfield-Aldeburgh Road.
