

At the Court at Buckingham Palace, the 21st day of December, 1954.

PRESENT,

The QUEEN'S Most Excellent Majesty in Council.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 9th day of December, 1954, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Thomas, Bishop of Carlisle (in witness whereof he has signed the Scheme), for effecting the union of the benefices of Irton and Drigg both situate in the diocese of Carlisle.

"SCHEME.

"1. *Union of Benefices.* The benefice of Irton and the benefice of Drigg shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Irton with Drigg', but the parishes of the said benefices shall continue in all respects distinct.

"2. *Taking effect of union.* Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect and the Reverend Ernest Amman Owens if he is then incumbent of the said benefice of Drigg shall with his consent (testified by his signature hereto), be the first incumbent of the united benefice.

"3. *Parsonage House.* Upon the union taking effect and pending the provision of a new house approved by us as suitable to be the house of residence for the incumbent of the united benefice, the parsonage house at present belonging to the benefice of Drigg shall be the house of residence of the incumbent of the united benefice.

"4. *Patronage.* After the union has taken effect the right of presentation to the united benefice shall be exercised by the patrons of the two benefices alternately, the patron of the benefice of Irton having the first presentation to the united benefice to be made after the union."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

And whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

"We, the Church Commissioners, acting in pursuance of the Archdeaconries and Rural Deaneries Act, 1874, and of the Acts mentioned therein, have prepared and now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend George, Bishop of Chichester (in witness whereof he has signed and sealed the same), with respect to the Archdeaconries of Lewes and Hastings, both in the diocese of Chichester, and to some of the rural deaneries within such archdeaconries.

"SCHEME

"As from the day on which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette and without any

assurance in the law other than such duly gazetted Order:—

"1. There shall be constituted and established within the Archdeaconry of Lewes two new rural deaneries which shall be called respectively 'The Rural Deanery of Kemp Town' and 'The Rural Deanery of Preston' and shall respectively comprise the parishes specified in the first and second parts of the Schedule hereto.

"2. There shall be transferred to the Rural Deanery of Brighton in the Archdeaconry of Lewes the parishes of Stanmer and Falmer now in the Rural Deanery of Lewes within the same Archdeaconry.

"3. There shall be transferred to the Rural Deanery of Battle and Bexhill in the Archdeaconry of Hastings the parish of Mountfield now in the Rural Deanery of Etchingham within the same Archdeaconry.

"4. There shall be transferred to the Rural Deanery of Seaford in the Archdeaconry of Hastings the parish of Folkington now in the Rural Deanery of Eastbourne within the same Archdeaconry.
