Greeting!

Whereas by an Act passed in a Session of Parliament holden in the third year of the reign of His late Majesty King Edward the Seventh, intituled "An Act to reorganise the Administration of the Patriotic Fund" the Patriotic Fund Commission constituted by Her late Majesty Queen Victoria by Warrant under the Royal Sign Manual dated the 7th day of October, 1854, was dissolved, and the property, rights, duties and liabilities thereof, and all property held in trust therefor, were transferred to and vested in the Royal Patriotic Fund Corporation established in pursuance of the provisions of the said Act:

And whereas pursuant to the provisions of the said recited Act and of Section 7 of the War Pensions (Administrative Provisions) Act, 1918, eight of the members of the said Corporation are appointed by Warrant under the Royal Sign Manual and hold office for a term of three years, being eligible for re-appointment:

And whereas in pursuance of the powers vested in Us by the said Acts We did, by various Warrants under Our Royal Sign Manual, appoint you the said Henry William Frederick Albert, Duke of Gloucester, together with the persons therein named to be members of the Royal Patriotic Fund Corporation:

Now know ye that We do by these Presents under Our Royal Sign Manual ordain and declare that you the said Henry William Frederick Albert, Duke of Gloucester, and you the said Sir John Tredinnick Crocker, Sir Arthur Charles Cosmo Parkinson, Sir Irvine Gordon Glennie, Elisabeth Hariott Kelly, Wilfred Harry Curtis and Robert Millar, shall be Members of the Royal Patriotic Fund Corporation, to exercise for the term of three years from the 1st day of January, 1955, together with Our Trusty and Well-beloved John Henry Francis Ludgate, Esquire, Commander of Our Most Excellent Order of the British Empire, who was appointed by Us on the 29th day of February, 1952, for a period of three years and in conjunction with the six members co-opted by the General Council, and the ex-officio

members specified in the First Schedule to the Act first above recited, the powers and duties transferred to that body as aforesaid, and generally to carry into effect the provisions of the said Act:

And We do further ordain that you the said Henry William Frederick Albert, Duke of Gloucester, shall be President of the General Council of the said Corporation.
