The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

REGULATIONS FOR THE RECRUITMENT OF CARTOGRAPHICAL DRAUGHTSMEN IN CERTAIN GOVERNMENT DEPARTMENTS AND CARTOGRAPHICAL DRAUGHTSMEN OR SURVEYORS IN THE ORDNANCE SURVEY OFFICE.

1. Age.
 SECTION I (Untrained). Candidates must be at least 16 and under 21 years of age on 1st January, 1955, i.e., they must have been born on or after 2nd January, 1934, and on or before 1st January, 1939. But a candidate who has served or is serving in H.M. Forces may deduct from his actual age the period of such service rendered before 1st January, 1955.

SECTION II (Trained). Candidates must be at least 18 years of age on 1st January, 1955, except that candidates for vacancies in the Ordnance Survey
