LONDON PASSENGER TRANSPORT ACT, 1933.

Waiting restrictions—Watford.

DESTRUCTIVE INSECTS AND PESTS ACTS, 1877 TO 1927.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Destructive Insects and Pests Acts, 1877 to 1927, entitled the Importation of Plants Order, 1955. The Order consolidates with amendments the Importation of Plants Orders, 1947 to 1954, the General Licence Orders made thereunder and the Importation of Raw Cherries Order, 1954, and it prohibits or restricts the importation into England or Wales (except under licence) of a revised list of plants and plant products. Provision is made for the official inspection of imported produce and for the disposal of any found to be unhealthy.

The Order will come into operation on the 1st April, 1955, except that certain provisions relating to imports of seeds will not become operative until 1st July, 1956.
