**WAGES COUNCILS ACTS, 1945 TO 1948.****RUBBER MANUFACTURING WAGES COUNCIL (GREAT BRITAIN).**

The Rubber Manufacturing Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for increases in statutory minimum remuneration by the amendment of the Rubber Manufacturing Wages Council (Great Britain) Wages Regulation Order, 1952 (Order R.U. (38)), as amended by the Rubber Manufacturing Wages Council (Great Britain) Wages Regulation (Amendment) Order, 1954 (Order R.U. (40)) and for the revocation of Order R.U. (40).

Particulars of the proposals may be obtained on application to the Secretary of the Wages Council at the address given below.

The Wages Council will consider any written representation with respect to the above-mentioned proposals which may be sent to it within fourteen days from 25th February, 1955.
