UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923.

A Statute made by the Governing Body of Corpus Christi College, in the University of Cambridge, on the 3rd March, 1955, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act, 1923.

THE GOVERNING BODY OF WINCHESTER COLLEGE having, on the 26th day of February, 1955, in virtue of the powers conferred upon them by the abovenamed Act, made a Statute in the terms appended hereto amending the existing Statutes of the said School, the said Statute is hereby published in the London Gazette in accordance with the provisions in that hebalf contained in the said Act

And Notice is hereby given that any person, body of persons, or body corporate, authorised in that behalf by the said Act, may, within two months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

A STATUTE to amend Statute XIV of the College concerning Exhibitions for Boys upon Leaving the

WE, the Warden and Fellows of Winchester College, being the Governing Body of Winchester College, do hereby, in exercise of the powers of the Public Schools Act, 1868, and of the Acts amending the same, and of all other powers enabling us in that behalf, resolve and enact as follows:—

STATUTE XIV.—Exhibitions for Boys upon Leaving THE SCHOOL.

1. There shall be a Consolidated Exhibition Fund comprising The Superannuates' Fund (instituted in the year 1729), the Bedminster Fund (established by deed of the 8th of April, 1742), and such other Funds, whether from benefactions or grants from College Funds, as may be directed by the Warden

College Funds, as may be directed by the Warden and Fellows.

2. The proceeds of this Fund shall be applied to the creation from time to time of Exhibitions to be awarded to boys upon leaving the School, under such conditions as the Warden and Fellows shall from time to time determine.

Such Exhibitions shall be awarded with the object of enabling the holders thereof to prepare themselves for a future profession, but it need not be made

a condition for the holding of any such Exhibition

a condition for the holding of any such Exhibition that the Exhibitoner shall enter at any University.

Provided that, if in any year the proceeds of the Fund cannot in the opinion of the Warden and Fellows usefully be applied as aforesaid, the surplus for that year (and so much of the proceeds in any subsequent year as is needed in order to implement any such award or supplementation as is hereinafter mentioned) may be applied in the award of Exhibitions or Bursaries in all respects similar to those payable out of the income of the College under Statutes XII and XIII or in the supplementation of any Exhibition or Bursary payable under those Statutes. Statutes.

3. The proceeds of the Cobden Fund (established by the Will of Edward Cobden) shall be applied towards an Exhibition to be given to a boy upon towards an Exhibition to be given to a boy upon leaving the School, under such conditions as the Warden and Fellows shall from time to time determine; but such Exhibition shall be tenable only by a member of the University of Oxford or of the University of Cambridge.

4. This Statute shall be substituted for Statute XIV of the Statutes of Winchester College approved by His late Majesty King George the Sixth in Council on the 21st day of July, 1950.

5. This Statute shall come into force and commence immediately upon the approval thereof by Her Majesty in Council.
