"We, the Church Commissioners, acting in pur-suance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parishes of Wymering and Portchester in the diocese of Portsmouth.

" SCHEME.

"Whereas we are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish: "And whereas we are satisfied that a suitable endowment therefor will be provided: "And whereas we have not approved within the said area any consecrated church as suitable to be

said area any consecrated church as suitable to be the parish church of the new parish: "Now, therefore, with the consent of the Right Reverend Launcelot, Bishop of Portsmouth (in testi-mony whereof he has set his hand and affixed his episcopal seal to this Scheme), we do humbly recom-mend and propose as follows, that is to say:—

"(a) As from the date of the licence thereto of a Minister the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a

and delineated on the map hereto annexed shall be a separate district for spiritual purposes. "(b) As from the date of the consecration of a church within the area, approved by us as suitable to be a parish church, or, if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish. "(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Michael and All Angels, Paulsgrove'. "2. Archdeaconry and Rural Deanery. "The district (or parish) shall be in the arch-deaconry of Portsmouth and in the rural deanery of Havant.

"All those contiguous parts (coloured pink on the map annexed hereto) of the parish of Portchester and the parish of Wymering which are bounded by an imaginary line commencing at a point on the boundary which divides the parish of Wymering from the parish of Southwick in the middle of Portsdown where the last-mentioned boundary turns northwards and continuing thence southwards to a point in the middle of the Portsdown to Fareham Road and continuing thence eastwards along the last-mentioned road to a point in the middle of Southwick Hill Road and continuing thence southwestwards for a distance of 12½ chains or therabouts to the wall or fence forming the northern side of Blakemere Crescent and continuing thence due southeastwards Crescent and continuing thence due southeastwards for a distance of 5¹/₂ chains or thereabouts to a point in the middle of Washbrook Road opposite to the middle of the western end of Harleston Road and continuing thence southwards along the middle of Washbrook Road to a point opposite to the middle of Clacton Road and continuing thence southeastof Clacton Road and continuing thence southeast-wards in a straight line to the northern end of the wall or fence forming the boundary between the houses or premises known as Nos. 5 and 7 Bell Road and continuing thence westwards along the walls or fences forming the northern boundaries of the houses or premises known as Nos. 5, 3 and 1 Bell Road and in a straight line in continuation thereof crossing Bryson Road and continuing thence westwards along the walls or thereof crossing Bryson Road and continuing thence westwards and southwestwards along the walls or fences forming the north eastern and north western boundaries of the houses or premises situate on the northwestern side of Bryson Road to their end and in a striaght line in continuation thereof to a point in the middle of Southampton Road and continuing thence due southwards for a distance of 17 chains or thereabouts to the High Water Mark of Ordinary Tides and continuing thence generally westwards along the said High Water Mark to the boundary of the City of Portsmouth and continuing thence generally northwards along the last-mentioned boundary to the boundary which divides the parish of Portchester from the parish of Southwick and continuing thence eastwards along the last-mentioned

boundary to its end and in continuation thereof along the boundary which divides the parish of Southwick from the parish of Wymering to the point in the middle of Portsdown where the last-mentioned boundary turns northward."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and sub-mission of this Scheme, have been duly complied with :

with: And whereas the said Scheme has been approved by Her Majesty in Council: Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Managere Measure

And Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forth-with registered by the Registrar of the said diocese of Portsmouth.

"2. The territory to be annexed to the parish of Merrow comprising: — "All those contiguous parts (coloured green on

the map) of the parishes of Christ Church, Guild-ford and Burpham with Sutton which lie to the north east of the middle of Boxgrove Road and to the south east of the middle of the Guildford to Cobham Line of the British Railways (Southern Region).

The territory to be annexed to the parish of Christ Church, Guildford comprising:— "All that part (coloured blue on the map) of the parish of Merrow which is bounded on the south west and on the north west by the parish of Christ Church, Guildford and on the remain-ing sides by an imaginary line commencing on the boundary which divides the parish of Christ Church, Guildford from the parish of Merrow at a point in the middle of Boxgrove Road and continuing thence southeastwards along the middle of the last named road to its junction with Merrow Road and continuing thence northeastwards along the middle of the last named road to a point opposite the middle of the footpath running along opposite the middle of the footpath running along the south western boundary of close number 265 on the map annexed hereto and continuing thence southeastwards to and along the middle of the
