WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 7th day of January, 1955, in the words and figures following, that is to say:

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Walter Hubert, Bishop of Blackburn (in witness whereof he has signed the Scheme), for effecting the union of the benefice of Scheme), for effecting the union of the benefice of

Blackburn and the benefice of Saint Paul, Blackburn, both situate in the diocese of Blackburn.

#### "SCHEME

"1. Union of Benefices. The benefice of Blackburn and the benefice of Saint Paul, Blackburn shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Saint Mary the Virgin and Saint Paul, Blackburn', and the parishes of the said benefices shall also be united into one parish for ecclesiastical purposes.

"2. Taking effect of union. (1) If upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the benefice of Saint Paul, Blackburn shall be vacant, the union shall forthwith take effect, but if upon that day the said benefice of Saint Paul, Blackburn shall

day the said benefice of Saint Paul, Blackburn shall be full the union shall take effect immediately upon the next vacation thereof.

"(2) If upon the union taking effect the Very Reverend William Kay is the incumbent of the benefice of Blackburn he shall with his consent (testified by his signature hereto) be the first incumbent of the

united benefice.

"3. Parish Church. The parish church of the parish of Blackburn (being the cathedral church of Blackburn) shall be the parish church of the united

"4. Registers. The marriage registers current at the church of Saint Paul, Blackburn, shall be dealt with in accordance with Section 62 of the Marriage Act, 1949, and the register books (if any) of baptism and burials and other the records and muniments deposited in the said church shall be transferred to the church of Saint Mary the Virgin, Blackburn.

"5. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Blackburn shall be the house of resithe benefice of Blackburn shall be the house of residence of the incumbent of the united benefice and the parsonage house belonging to the benefice of Saint Paul, Blackburn, and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith shall be sold and disposed of by us for a nominal consideration to the Blackburn Diocesan Board of Finance as trustees to be used as a house of residence for an assistant to be used as a house of residence for an assistant curate of the united benefice.

"6. Taking down of Church. (1) As soon as conveniently may be after the union has taken effect the church of Saint Paul, Blackburn, shall be taken down and the materials and site thereof, together with any ground annexed thereto and necessary for the use and enjoyment thereof, shall be sold and disposed of by us, at such time or times and in such manner in all respects as to us shall seem expedient subject to the conditions and restrictions imposed by the said Measures. by the said Measures.

"(2) The net proceeds to arise from such sale or

sales after payment of the expenses attendant there-on and upon the taking down of the church and all other expenses incidental to these matters shall be carried to the curacy fund referred to in clause 8 of

- this Scheme.

  "(3) The font, communion table and plate used for the purpose of the Holy Communion in the said church of Saint Paul, Blackburn, shall not be sold, but shall in accordance with the provisions of the said Union of Benefices Measures and as the bishop of the said diocese of Blackburn may direct, be trans ferred to some other church or churches within the ferred to some other church or churches within the said diocese and the bells, organ and other furniture and fittings of the said church of Saint Paul, Blackburn, or such of them as the said bishop shall select, shall be removed to any other church or chapel or churches or chapels within the said diocese which the bishop may direct or shall be sold and in such case the proceeds shall be added to the said curacy fund.

"8. Employment of a curate or clerical or lay assistance.

"(1) Upon the union taking effect the incumbent shall, in order to assist him in performing the duties of the united benefice, employ a curate or curates or such other clerical or lay assistance as the bishop

of the diocese may from time to time direct.

"(2) Upon the union taking effect there shall be appropriated as a fund towards the cost of providing

such assistance as aforesaid—
