

"(b) a capital sum of £914 4s. 1d. producing an annual income of £32 17s. 9d. now held by us for the endowment of the benefice of Saint Paul, Blackburn,

"(c) an annuity of £194 charged upon our general fund in favour of the benefice of Saint Paul, Blackburn,

"(d) a capital sum of £2,022 14s. 11d. producing an annual income of £82 1s. 4d. now held by us for the endowment of an assistant curacy in the parish of Saint Paul, Blackburn, and

"(e) an annuity of £65 5s. 0d. charged upon our general fund and payable conditionally upon the employment of an assistant curate in the parish of Saint Paul, Blackburn,

and the income of the fund so appropriated shall be paid by us to the diocesan board of finance of the diocese of Blackburn as trustees to apply the same accordingly.

"9. *Trust Funds.* Upon the union taking effect two sums of 3½ per cent. Conversion Stock held by the Blackburn Diocesan Board of Finance (hereinafter called 'the said Board') pursuant to the Will of the late James Edward Fielding, that is to say, (a) £4,690 6s. 0d. 3½ per cent. Conversion Stock held by the said Board upon trust to apply the income towards the maintenance of an assistant curate to be employed in the parish of Saint Paul, Blackburn and (b) £3,517 14s. 4d. 3½ per cent. Conversion Stock held by the said Board upon trust for the general expenses of Saint Paul's Church, Blackburn, or towards the building of a new church for the parish of Saint Paul, Blackburn, and (c) such part of the income arising from time to time on a sum of £2,345 3s. 0d. 3½ per cent. Conversion Stock held by the said Board as under the Will of the said James Edward Fielding is applicable upon certain conditions towards the general expenses of Saint Paul's Church, Blackburn, or towards the building of a new church for the parish of Saint Paul, Blackburn, shall be applied for the like purposes or objects for the benefit of or in connection with the cathedral church of Saint Mary the Virgin, Blackburn, or the united parish of Saint Mary the Virgin and Saint Paul, Blackburn."

And Whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with:

And Whereas the said Scheme has been approved by Her Majesty in Council:

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to affirm the said Scheme and to order that it shall be and become effectual in law immediately upon the publication of this Order in the London Gazette.

THE PUBLIC SCHOOLS ACT, 1868.

THE GOVERNING BODY OF SHREWSBURY SCHOOL having, on the 6th day of April, 1955, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending the existing Statutes of the School, the said Statute is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act.

And Notice is hereby given, that any person, body of persons, or body corporate, authorized in that behalf by the said Act, may, within two months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

STATUTE made by the Governing Body of Shrewsbury School on the sixth day of April, one thousand nine hundred and fifty-five.

WE, THE GOVERNING BODY OF SHREWSBURY SCHOOL (otherwise Shrewsbury Free Grammar School) do hereby in exercise of the powers of section 7 of the Public Schools Act, 1868, and the Acts amending the same and all other powers enabling us in that behalf enact as follows:—

Amendment to Statute II. Constitution of the Governing Body.

In Paragraph 1 of the Statute, on line 22 thereof, delete the words "Three members to be elected by the Governing Body" and substitute therefor

the words "Five members to be elected by the Governing Body".

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 22nd April, 1955, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £230,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 25th April, 1955, to Saturday, the 30th April, 1955, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part, and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.
