EXPLANATORY NOTE.

These regulations contain miscellaneous amend-These regulations contain miscellaneous amendments to the National Insurance (Determination of Claims and Questions) Regulations, 1948. Regulation 2 amends the procedure at hearings before local tribunals by allowing the claimant to be represented by persons who are barristers, advocates or solicitors, provided they are not appearing in their professional capacity. Regulation 3 amends the provisions relating to appeals to the Commissioner by giving an association the right to appeal on behalf of a person claiming benefit by virtue of a deceased member's insurance. Regulation 4 amends the procedure for the determination of questions by the procedure for the determination of questions by the Commissioner by providing that he may have the assistance of an assessor or assessors if he con-siders that a question of fact of special difficulty arises and by providing that he may refer any question arising for his decision to a registered medical practitioner for examination and report.
