TOWN AND COUNTRY PLANNING ACT, 1947.

The Minister of Transport and Civil Aviation hereby gives notice that he has made an Order under s. 49 of the Town and Country Planning Act, 1947, entitled "The Stopping up of Highways (Lancashire) (No. 4) Order, 1955," authorising the stopping up of Daisy Street, Back Mount Street and a length of Birch Street, Heywood, Lancs., and requiring the provision of a new footpath.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Town and Country Planning Act, 1947, or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may within 6 weeks of the 5th August, 1955, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

**NOTICE OF SEIZURE UNDER THE CUSTOMS
AND EXCISE ACT, 1952.**

Pursuant to section 275 (5) of the Customs and Excise Act, 1952, and paragraph 1 of the Seventh Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that, by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely fourteen cases, marked A.C.E. Manchester 706, 708, 711, 713/719, 721, 722, 724 and 725, containing 47/8" dyed nylon piece goods imported on 3rd May, 1955, in s.s. "Ardetta" at Salford, valued at £5,585 3s. 9d. and entered to prime entry 0565/9.5.55, have been seized as liable to forfeiture upon the grounds:—

- (i) that the said goods were imported contrary to the prohibition for the time being in force with respect thereto, namely the Import of Goods (Control) Order, 1954, made under the Import, Export and Customs Powers (Defence) Act, 1939;
 - (ii) that on 1st June, 1955, an officer of Customs and Excise required Allied Commercial Exporters, Ltd., being the person possessing and having control of the said goods, to furnish proof that the importation of the said goods was not unlawful by virtue of the Import of Goods (Control) Order, 1954, and such proof has not been furnished to the satisfaction of the Commissioners of Customs and Excise;
 - (iii) that the said goods were found not to correspond with the entry made thereof because the entry declared the country of origin of the said goods to be Italy when, in fact, the country of origin of the said goods was not Italy.
- Whereby and by force of section 44 (b) and (c) of the Customs and Excise Act, 1952, and section

3 (1) and (3) of the Import, Export and Customs Powers (Defence) Act, 1939, the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture, you must, within one month from the date of this notice of seizure, give notice of your claim in accordance with the provisions of paragraph 3 of the Seventh Schedule to the Customs and Excise Act, 1952, and specifying the name and address of a solicitor in England who is authorised to accept service of process and to act on your behalf. In default of such notice, the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
