The QUEEN has been graciously pleased to approve the following award in recognition of gallant and distinguished services in Malaya:—

The Military Medal.

No. 23211237 Private Patrick Paul O'CALLAGHAN, The Royal Hampshire Regiment.

On 18th June at 0145 hrs. 12 Platoon were in Camp in the South Swamp. It was raining hard and the night was very dark. The Camp was laid out as a rough circle. The Platoon Commander—a Sergeant—was himself a sentry in the middle of the camp following normal practice. Private O'CALLAGHAN was asleep in his hammock on the edge of the camp

Private O'CALLAGHAN was awakened by someone moving his hands over his body. He moved and was struck a heavy blow on the head with a heavy Malay knife. The blow was sufficiently violent to fracture his skull. He shouted—"Sergeant" jumped from his hammock knocked over one bandit and caught hold of another. He felt the muzzle of a weapon pressed against his stomach, wrested it away from the bandit and turned it against its owner. He fired twice but both rounds were misfires. He away from the bandit and turned it against its owner. He fired twice but both rounds were misfires. He seized the bandit by the throat with one hand and began hitting him with the other. He was then slashed across the feet with the knife sufficiently violently to cut him to the bone. He fell down and the bandit ran away.

Next morning a search was made of the area and it was apparent that four or five bandits were concerned. In their haste to escape they had left behind one carbine, two knives and a sack containing

one car clothing.

Private O'Callaghan was evacuated by helicopter Private O'CALLAGHAN was evacuated by helicopter that afternoon some fourteen hours after the incident. He was clearly suffering from severe loss of blood and was in considerable pain. At no time did he utter a word of complaint. His conduct throughout was outstanding and had he not shown so much courage and presence of mind under the most adverse conditions it is more than likely that his platoon would have suffered further casualties and would have lost weapons.
